COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault-Felony

Minnesota Statute: 609.2242.4

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 08/03/2026

Control #(ICR#): 26024375

Charge Description: On or about August 3, 2026, in the County of Blue Earth, Minnesota, Nyabuoy Ochan Deng did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflicted or attempted to inflict bodily harm upon another and has two or more previous qualified domestic violence-related offense convictions or adjudications of delinquency within ten years following discharge from sentence or disposition for that offense.

COUNT II

Charge: Domestic Assault-Felony

Minnesota Statute: 609.2242.4

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 08/03/2026

Control #(ICR#): 26024375

Charge Description: On or about August 3, 2026, in the County of Blue Earth, Minnesota, Nyabuoy Ochan Deng did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death and has two or more previous qualified domestic violence-related offense convictions or adjudications of delinquency within ten years following discharge from sentence or disposition for that offense.

STATEMENT OF PROBABLE CAUSE

On August 3, 2026, at approximately 4:41 AM, Blue Earth County dispatch received a 911 call from Victim 1 that stated that her daughter was refusing to leave and fighting and hitting her.

Officers responded to the address in Mankato, Minnesota, Blue Earth County. Officers made contact with Victim 1 and Nyabuoy Ochan Deng, dob 4/29/2005.

Deng claimed that Victim 1 struck her first and then the fight was mutual. Deng was unable to provide specifics about how she was struck by Victim 1. Deng said Witness 1 witnessed the incident.

Victim 1 stated that Deng does not live at the residence but was staying there. Deng got upset over some clothing. Deng was yelling and woke up the children in the house. Deng then started hitting Victim 1 with two closed fists. Victim 1 admitted to hitting Deng back.

Witness 1 stated that Victim 1 told Deng she was being too loud. Deng responded by telling Victim 1 she would fight her. Deng proceeded to hit Victim 1 which began the altercation.

Deng has a previous gross misdemeanor domestic assault conviction on July 15, 2025 in court file number 07-CR-25-1774 and a previous juvenile adjudication for 5th degree assault on October 31, 2018, in court file number 07-JV-18-4302.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
