The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Assault-2nd Degree-Dangerous Weapon**

Minnesota Statute: 609.222.1, with reference to: 609.11.4

Maximum Sentence: 7 years or \$14,000 fine or both.

Offense Level: Felony

Offense Date (on or about): 03/17/2026

Control #(ICR#): 26005350

Charge Description: On or about March 17, 2026, in the County of Blue Earth, Minnesota, Brooke Michelle Carr, did assault another with a dangerous weapon.

**COUNT II**

**Charge: Emergency Telephone Calls/Communications - Interrupt, Interfere, Impede, Disrupt 911 Call**

Minnesota Statute: 609.78.2(1)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 03/17/2026

Control #(ICR#): 26005350

Charge Description: On or about March 17, 2026, in the County of Blue Earth, Minnesota, Brooke Michelle Carr did and intentionally interrupt, disrupt, impede, or interfere with an emergency call or intentionally prevent or hinder another from placing an emergency call.

**COUNT III**

**Charge: Domestic Assault-Misdemeanor-Intentionally Inflicts/Attempts to Inflict Bodily Harm on Another**

Minnesota Statute: 609.2242.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 03/17/2026

Charge Description: On or about March 17, 2026, in the County of Blue Earth, Minnesota, Brooke Michelle Carr, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another.

#### **COUNT IV**

**Charge: Domestic Assault-Misdemeanor-Commits Act to Cause Fear of Immediate Bodily Harm or Death**

Minnesota Statute: 609.2242.1(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 03/17/2026

Control #(ICR#): 26005350

Charge Description: On or about March 17, 2026, in the County of Blue Earth, Minnesota, Brooke Michelle Carr, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death.

## STATEMENT OF PROBABLE CAUSE

On March 17, 2026, at approximately 7:54 PM, deputies of the Blue Earth County Sheriff's office were dispatched to a residence in Blue Earth County on report of a domestic incident involving a knife. The caller was identified as Victim 1 who was reporting being assaulted by his girlfriend, Brooke Michelle Carr (dob 11/02/1995).

Deputies arrived and made contact with Victim 1. Deputies also made contact with Carr.

Victim 1 stated that an argument ensued over supper. During the verbal argument, Carr grabbed Victim 1 by the front of his shirt and pulled it down. Victim 1 said that he pushed Carr back to get her away from him. She fell to the ground.

Victim 1 said that he went into the kitchen to get away from Carr and called 911. Carr followed him. When calling 911, Carr tried to knock the phone out of his hands. Carr procured a small pairing knife in her hand. Carr then raised the knife in her hand and said, "you've been stabbed before, do you wanna get stabbed again?" Victim 1 said he was able to swat the knife out of Carr's hand. Carr then went upstairs.

Officers located the knife.

Deputies observed visible marks on Victim 1's neck and his shirt was stretched by the collar.

Carr stated she didn't want anyone to get in trouble. Carr stated that Victim 1 grabbed her by the neck and slammed her down. Deputy Purvis did not observe any injuries to Carr's neck. When asked for more information, Carr would not answer. Carr denied using a knife. Carr stated she was upset about Victim 1 calling 911.

Carr submitted to a portable breath test that resulted in a .257 alcohol content. She was taken to a detoxification facility. A warrant is requested.

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
