The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Obscene Material-Exhibit, sell, print, offer to sell give away, circulate, publish, distribute**

Minnesota Statute: 617.241.2(a), with reference to: 617.241.3

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 02/03/2026

Control # (ICR#): 26003473

Charge Description: On or about February 3, 2026, in the County of Blue Earth, Minnesota, Billy Curtis Harrison did, knowing or with reason to know its content and character, exhibit, sell, print, offer to sell, give away, circulate, publish, distribute or attempt to distribute any obscene material.

**COUNT II**

**Charge: Indecent Exposure-Engage in Lewd/Indecent Behavior**

Minnesota Statute: 617.23.1(3)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 02/03/2026

Control # (ICR#): 26003473

Charge Description: On or about February 3, 2026, in the County of Blue Earth, Minnesota, Billy Curtis Harrison did in any public place or in any place where others are present, engage in any open or gross lewdness or lascivious behavior, or any public indecency.

## STATEMENT OF PROBABLE CAUSE

On February 3, 2026, law enforcement were dispatched to Business 1 located in Mankato, Within Blue Earth County, Minnesota for a disturbance. Witness 1 reported the disturbance to law enforcement and indicated that Staff of Business 1 made a complaint regarding a white Dodge Truck bearing Minnesota license plate LXZ972. According to Witness 1, Staff advised the driver of the truck had shown pictures of naked women (specifically: "nudes of vaginas on his phone").

Officer Kristian Marzolf and Sergeant Jacob Price of the Mankato Department of Public Safety responded to Business 1's and spoke with Witness 2 who is employed at Business 1. Witness 2 informed law enforcement that she was working at the first drive-thru window and observed Harrison's truck approach and that the sole occupant of the vehicle was holding his phone between his chest and the steering wheel with the screen facing towards her. Witness 2 stated that the screen was illuminated and displaying an image of a naked male. Witness 2 described image as a white male whose appearance was consistent with the driver, but it did not include his face. Witness 2 described the photograph as a naked white male standing facing the camera visible from his shins up to his shoulders. Witness 2 then accepted payment and returned his card.

Witness 2 then informed her manager to alert Witness 3 who was working at the second drive-thru window. Witness 3 stated that while working the second window she observed Harrison resting his right arm on his knee or leg while holding his phone at chest height with the phone angled towards her. Witness 3 observed the phone screen displaying several thumbnail images as if it was a digital gallery. Witness 3 described the images as close ups of male and female genitals, including an erect penis. Witness 3 indicated that Harrison was watching her and seemed to wait for her to see the nude images before putting his phone out of view. Witness 2 and Witness 3 indicated that the images appeared to be intended for sexual gratification.

Sergeant Price located the white Dodge Ram truck and conducted a traffic stop. The sole occupant was identified by law enforcement as Billy Curtis Harrison (1/16/1991). Harrison indicated that he was recently at Business 1. Having spoken to Witness 2 and Witness 3 Harrison was informed that he was under arrest. Harrison was then transported to the Blue Earth County Jail.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
