The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Murder - 2nd Degree - With Intent-Not Premeditated

Minnesota Statute: 609.19.1(1) Maximum Sentence: 40 years

Offense Level: Felony

Offense Date (on or about): 03/17/2025

Control #(ICR#): 25007280

Charge Description: On or about March 17, 2025, in the County of Blue Earth, Minnesota, Michael Lee Miller did cause the death of a human being with intent to effect the death of the person or another, but without premeditation.

STATEMENT OF PROBABLE CAUSE

On March 18, 2025, at 3:03 AM, the Mankato Department of Public Safety was dispatched to a disturbance at Business 1 in Mankato, Blue Earth County. Dispatch reported an individual was inside the store breaking stuff and the 911 call had disconnected. Dispatch attempted calls back to the caller. During the call, dispatch could hear sounds of an altercation. As officers were responding, dispatch advised they received a second call from Witness 1 who stated they had fled Business 1.

Officers arrived on scene and searched Business 1. Officer Honetschlager located broken glass near the back room of Business 1 as Officers Rutz and Johnson searched additional areas of Business 1. Officer Rutz and Johnson found Victim unresponsive behind the counter and surrounded by a large pool of blood. Officers observed multiple lacerations consistent with a knife wound on Victim's neck, head, back, and leg. Officers began administering medical aid. Victim was transported to the hospital emergency department where he was declared deceased. A provisional autopsy was conducted and noted Victim had 43 sharp force injuries. Victim's cause of death was determined to be multiple sharp force injuries and his manner of death homicide.

Using surveillance images from Business 1 and a description provided by Witness 1, officers identified the suspect as Michael Lee Miller (DOB 01/07/1997).

Witness 1 reported to Officer Janak that Miller entered Business 1 and had a large knife with a white handle. Miller went to the refrigerator section and selected some meat and started to eat it. Miller then got a water from the cooler. Witness 1 told Miller he needed to pay for the items. Victim, who was also working at Business 1, told Witness 1 to call the cops. Witness 1 went to the back room to collect images of Miller to provide to law enforcement. While in the back room, Witness 1 observed Miller walking towards him so he shut the door and locked it. Miller then began hitting the glass on the door until it broke. Witness 1 left Business 1 and called 911.

Officer Janak reviewed surveillance video at Business 1 and observed Miller entering Business 1 shortly before 3:00 AM. Miller has a large knife in his left hand. Miller selects food and a water out of the fridge. Miller uses the knife to open the food. Miller is seen walking behind the counter and confronting Victim. Miller cornered Victim behind the register and throws him to the ground and uses the knife to stab Victim multiple times. Miller then exited Business 1 and headed westbound on foot.

The Minnesota River Valley Tactical Response Team took Miller into custody at his residence, which is located westbound from Business 1. While being arrested, Miller asked if that guy survived.

Miller was read his Miranda rights and agreed to speak with Detectives Sack and Hullopeter. When asked why he went to Business 1, Miller stated "like god is telling me." Miller also stated he was hearing voices and that he needs to destroy and burn everything down. Miller stated he walked from his house with a knife and a lighter and walked there and did it. He stated "I wasn't gonna knife the guy at first. I was just gonna set it on fire, the place on fire." Miller stated he threw the knife in a dumpster and he described the knife as a big kitchen knife with a white handle. Miller stated he had helped himself to some snacks and water and he was asked if he was going to pay for it, to which he said no. Miller stated one guy, Witness 1, was trying to escape in the back room and he followed him but Witness 1 locked the door. He then smashed his head on the window until it broke. Miller stated he turned his attention to the guy behind the cash register and that Victim tried to grab the knife and he wrestled it back from Victim and he started stabbing him. Detective Sack noted that Miller stated "I smiled for some reason 'cause apparently something was working, but when he tried to escape from me...that was a no for me. So I just, he tried to defend himself, but I got him." Miller stated he did not remember using the knife, he thinks it was just blunt rage. When

asked where he stabbed Victim, Miller stated after it was over he looked at Victim and said he thinks he got him in the neck.

A knife with a white handle and an approximately 9 inch blade was recovered in the dumpster where Miller stated he threw it. The knife was bent at the point and covered in apparent blood.

A search of Miller's residence was completed. Detectives located knives similar to the knife recovered in the dumpster, suspected blood in various locations including in Miller's bedroom, the dining area, the living area, and the stairwell in the garage.

The investigation is ongoing.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
