The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Threats of Violence-Reckless Disregard Risk**

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 12/31/2025

Control #(ICR#): 25037149

Charge Description: On or about December 31, 2025, in the County of Blue Earth, Minnesota, Andrew John Lehn, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

## STATEMENT OF PROBABLE CAUSE

On December 31, 2025, at approximately 10:00 AM, Officer Carver Christianson with the Mankato Department of Public Safety, was dispatched on a threats complaint at a business in the City of Mankato. Ofc. Christianson spoke with Victim 1 who reported receiving a threatening message on his company's Facebook page.

Ofc. Christianson spoke with Victim 1 who stated that he manages the business. Victim 1 stated that he had received a message on the businesses Facebook page from an individual identified as Andrew John Lehn.

The message stated, "I'm recording your Internet address and have a cousin in the FBI... Let's play who finds each other first... I have a horrible credit score and nothing to lose... I will be that random person that kills you and your family in your sleep. In about 2 years. Locked in."

Ofc. Christianson located Lehn and spoke with him over the phone. Initially Lehn claimed he never threatened anyone. Lehn then changed his story and stated that he had been drinking a little and "might" have said something. Lehn stated he did not "recall" sending the message, but stated it was nothing he would act on and claimed it was not a threat.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
