COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Burglary-1st Deg-Assault Person In Build/On Property

Minnesota Statute: 609.582.1(c)

Maximum Sentence: 20 years or \$35,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 06/03/2026

Control #(ICR#): 26017124

Charge Description: On or about June 3, 2026, in the County of Blue Earth, Minnesota, Shawnveon Detrell Holiday did enter a building without consent and with intent to commit a crime, or entered a building without consent and committed a crime while in the building, either directly or as an accomplice and the burglar assaults a person within the building or on the building's appurtenant property.

COUNT II

Charge: Burglary-1st Deg-Dwelling-Occupied-Non-Accomplice Present

Minnesota Statute: 609.582.1(a), with reference to: 609.582.1a

Maximum Sentence: 20 years or \$35,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 06/03/2026

Control #(ICR#): 26017124

Charge Description: On or about June 3, 2026, in the County of Blue Earth, Minnesota, Shawnveon Detrell Holiday did enter a building without consent and with intent to commit a crime, or entered a building without consent and committed a crime while in the building, either directly or as an accomplice and the building is a dwelling and another person, not an accomplice, is present in it when the burglar enters or at any time while the burglar is in the building.

COUNT III

Charge: Domestic Assault - By Strangulation

Minnesota Statute: 609.2247.2

Maximum Sentence: 3 years or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 06/03/2026

Control #(ICR#): 26017124

Charge Description: On or about June 3, 2026, in the County of Blue Earth, Minnesota, Shawnveon Detrell Holiday did assault a family or household member by strangulation.

COUNT IV

Charge: Emergency Telephone Calls/Communications - Interrupt, Interfere, Impede, Disrupt 911 Call

Minnesota Statute: 609.78.2(1)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 06/03/2026

Charge Description: On or about June 3, 2026, in the County of Blue Earth, Minnesota, Shawnveon Detrell Holiday did and intentionally interrupt, disrupt, impede, or interfere with an emergency call or intentionally prevent or hinder another from placing an emergency call.

COUNT V

Charge: Criminal Sexual Conduct - 5th Degree - Nonconsensual sexual contact

Minnesota Statute: 609.3451.1a(1)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 06/03/2026

Control #(ICR#): 26017124

Charge Description: On or about June 3, 2026, in the County of Blue Earth, Minnesota, Shawnveon Detrell Holiday did engage another in nonconsensual sexual contact.

COUNT VI

Charge: Domestic Assault-Misdemeanor-Intentionally Inflicts/Attempts to Inflict Bodily Harm on Another

Minnesota Statute: 609.2242.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 06/03/2026

Control #(ICR#): 26017124

Charge Description: On or about June 3, 2026, in the County of Blue Earth, Minnesota, Shawnveon Detrell Holiday, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another.

COUNT VII

Charge: Assault-5th Deg-Inflict or Attempt Bodily Harm

Minnesota Statute: 609.224.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 06/03/2026

Control #(ICR#): 26017124

Charge Description: On or about June 3, 2026, in the County of Blue Earth, Minnesota, Shawnveon Detrell Holiday, did intentionally inflict or attempted to inflict bodily harm upon another.

STATEMENT OF PROBABLE CAUSE

On June 3, 2026, at approximately 1:07 AM, officers of the Mankato Department of Public Safety were dispatched to a domestic disturbance occurring at a residence in the city of Mankato, County of Blue Earth, State of Minnesota. Dispatch received a 911 call from Victim 1 stating that her boyfriend was assaulting her and refusing to leave. Victim 1 stated that her eight-year-old daughter was also present.

Officers arrived and made contact with Victim 1 and Shawnveon Detrell Holiday, dob 8/14/1997. Holiday immediately began yelling at officers. He was detained.

Holiday told officers he came up from Mississippi to visit Victim 1. Holiday confirmed they were dating. Holiday admitted to getting into an argument with Victim 1 and pushing her.

Officers observed some injuries on Victim 1.

Victim 1 provided a statement to law enforcement. Victim 1 stated that her and Holiday had been dating for approximately two weeks. Around midnight, Holiday wanted to have sex with Victim 1 but Victim 1 did not want to so she told Holiday no. Despite this, Holiday held Victim 1 down by her wrists with her arms above her head. Holiday then grabbed Victim 1's breasts and smacked her butt. Victim 1 stated she told Holiday no. Holiday stated that she is his girlfriend and he should be able to have it when he wants.

Victim 1 stated Holiday stopped and she fell asleep. Victim 1 stated she then woke up with Holiday in her room again. Holiday was accusing Victim 1 of cheating on Holiday. Holiday told Victim 1 that she was going to have sex with him. Victim 1 stated Holiday then choked her which caused her trouble breathing. Victim 1 stated she was able to kick Holiday off of her and told him to leave the residence. Holiday came back and slapped Victim 1 on the side of her face. Victim 1 stated she jumped out of bed and called 911.

Victim 1 stated she went into her daughter's room and locked the door with herself and her daughter. Victim 1 stated she could hear Holiday on the phone telling someone that he was going to "fuck her up." Victim 1 stated that Holiday then broke her daughter's door. A struggle then ensued. At one point, Holiday grabbed the phone away from Victim 1 while she was talking with dispatch.

Officers observed damaged Victim 1's daughter's door.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
