The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Threats of Violence-Reckless Disregard Risk**

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 01/04/2026

Control #(ICR#): 26000424

Charge Description: On or about January 4, 2026, in the County of Blue Earth, Minnesota, Samantha Ann Boeckman, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

**COUNT II**

**Charge: Obstruct Legal Process-Interfere w/Peace Officer**

Minnesota Statute: 609.50.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 01/04/2026

Control #(ICR#): 26000424

Charge Description: On or about January 4, 2026, in the County of Blue Earth, Minnesota, Samantha Ann Boeckman, did obstruct, resist, or interfere with a peace officer while the officer is engaged in the performance of official duties.

**COUNT III**

**Charge: Assault-5th Degree-Fear of Bodily Harm or Death**

Minnesota Statute: 609.224.1(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 01/04/2026

Control #(ICR#): 26000424

Charge Description: On or about January 4, 2026, in the County of Blue Earth, Minnesota, Samantha Ann Boeckman, did commit an act with intent to cause fear in another of immediate bodily harm or death.

## STATEMENT OF PROBABLE CAUSE

On January 4, 2026, officers of the Mankato Department of Public Safety were dispatched to a group home on report of an assault by someone living at the home. The home was located in Mankato, Minnesota, Blue Earth County.

Officers spoke with Victim 1—a staff member. Victim 1 stated that Samantha Anne Boeckman (DOB 5/21/2001) became upset when Victim 1 moved Boeckman's laundry from the washer to the dryer. Boeckman began pounding her first on the back door. Boeckman then told Victim 1 that it will be her next time, not the door. Boeckman also said she would kill Victim 1.

Victim 1 said she was fearful that Boeckman would assault her. Victim 1 said that she was fearful that Boeckman would try to kill her and Boeckman started walking towards her when she threatened her.

Officers made contact with Boeckman. Boeckman resisted officers, including trying to shut the door on them, kicking her legs, and not listening to commands. Eventually, Boeckman was detained.

Boeckman was taken to the hospital and released to her father who was going to coordinate with the group home to determine a future plan.

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
