COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault - 4th Deg - Physician, nurse or other emergency room personnel

Minnesota Statute: 609.2231.2(a)(2), with reference to: 609.2231.2(b)

Maximum Sentence: 3 years or \$6,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 08/08/2026

Control #(ICR#): 26025053

Charge Description: On or about August 8, 2026, in the County of Blue Earth, Minnesota, Marcelina Skye Samora, did, physically assault and inflict demonstrable bodily harm upon a physician, nurse, or other person providing health care services in a hospital emergency department.

STATEMENT OF PROBABLE CAUSE

On August 8, 2026, Officer Christianson of the Mankato Department of Public Safety was dispatched to the emergency room in Mankato, Minnesota, Blue Earth County, on report that a patient had assaulted a staff member.

Officer Christianson arrived at the emergency room and made contact with Witness 1, a registered ER nurse. Witness 1 stated that the patient was Marcelina Skye Samora (dob 4/29/2005). Witness 1 stated Samora was intoxicated and suicidal. At one point, Samora became upset and kicked Victim 1, an ER nurse, in the face.

Officer Christianson observed visible swelling and redness on Victim 1's face.
