COMPLAINT

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drivers' Licenses-Driving restrictions-Drive/operate/control motor vehicle w/o ignition interlock.

Minnesota Statute: 171.09.1(g)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 07/11/2026

Control #(ICR#): 26014613

Charge Description: On or about July 11, 2026, in the County of Blue Earth, Minnesota, Raimond R Jack, did, while holding a restricted license issued under section 171.306, drive, operate, or be in physical control of any motor vehicle that is not equipped with a functioning ignition interlock device certified by the commissioner.

COUNT II

Charge: Traffic-Drivers License-Driving After Cancellation

Minnesota Statute: 171.24.3, with reference to: 171.24.3

Maximum Sentence: 90 days or \$1,000 fine or both

Offense Level: Misdemeanor

Offense Date (on or about): 07/11/2026

Control #(ICR#): 26014613

Charge Description: On or about July 11, 2026, in the County of Blue Earth, Minnesota, Raimond R Jack did after being given notice, or reasonably should have known of the cancellation, disobeyed the order by operating in this state any motor vehicle, the operation of which requires a driver's license, while her/his license or privilege was canceled.

STATEMENT OF PROBABLE CAUSE

On July 11, 2026, Deputy Nicholas Lewis of the Blue Earth County Sheriff's Office was on patrol located in the lot of Lake Park in the City of Eagle Lake, Minnesota. Earlier Deputy Lewis was notified via his ALPR that the registered owner of a parked gray Ford Edge (SXH349) had a cancelled driving status, however during that time the vehicle was unoccupied.

Later, the same day, Deputy Lewis observed the vehicle leaving the parking lot, and the driver of the vehicle matched the registered owner's description. Deputy Lewis then conducted a traffic stop in the City of Eagle Lake within the County of Blue Earth.

Upon making contact with the driver Deputy Lewis informed the driver that the registered owner of the vehicle Raimond Jack (DOB 06/28/1989), had a cancelled driving status. Deputy Lewis then asked for his name. The driver then verbally identified himself as Raimond Jack and produced a paper copy of his driver's license, confirming his identity. Jack informed Deputy Lewis of the following:

- He was unaware that his driving privileges had been cancelled as he had not received any notification in the mail.
- He no longer lived at the registered address in Le Sueur and now resides in Springfield.
- He had moved one to two months earlier and had not updated his address
- He acknowledged that his vehicle was not equipped with the required ignition interlock device which is required and has owned the vehicle for approximately 6 months but had been unable to schedule an interlock installation appointment.

Jack's driving status was cancelled on June 28, 2026.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
