The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault-Misdemeanor-Intentionally Inflicts/Attempts to Inflict Bodily Harm on Another

Minnesota Statute: 609.2242.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 01/22/2026

Control #(ICR#): 26001343

Charge Description: On or about January 22, 2026, in the County of Blue Earth, Minnesota, Cheyanne Patricia Gutierrez, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another.

COUNT II

Charge: Disorderly Conduct - Brawling or Fighting

Minnesota Statute: 609.72.1(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 01/22/2026

Control #(ICR#): 26001343

Charge Description: On or about January 22, 2026, in the County of Blue Earth, Minnesota, Cheyanne Patricia Gutierrez, did, in a public or private place, knowing, or having reasonable grounds to know it will, or will tend to, alarm, anger or disturb others or provoke an assault or breach of the peace, engaged in brawling or fighting.

STATEMENT OF PROBABLE CAUSE

On January 22, 2026 at approximately 6:25 am, Blue Earth County Sheriff's Deputy Elijah Blakesley was dispatched to rural Madelia for a complaint regarding a domestic assault.

When Deputy Blakesley arrived at the residence, the Victim and Cheyanne Patricia Gutierrez, DOB: 07/18/1998, had been separated, but were still verbally arguing with one another. The Deputy made contact with Gutierrez, who stated the following: that she was so mad at the Victim that "she wanted to beat him up." She stated that the Victim had thrown vodka in her eyes while she was sleeping and that he had beat her up. She stated that she had chased the Victim into the bathroom, so that she could beat him up and that she had attacked him and punched in the back of the head several times. She stated that her left wrist was swollen, from her punching him. She stated that she had been trying to hurt the Victim. She stated that the Victim was her friend and had been staying at her home for "about a week." Gutierrez agreed to provide a PBT, which indicated a BAC of .158. Gutierrez also stated that she had used methamphetamines the day before.

Deputy Blakesley spoke to the Victim, who also agreed to provide a PBT sample, which indicated a BAC of .075. The Victim denied throwing vodka at Gutierrez, or attacking her. He stated that she has been diagnosed with schizophrenia. The Victim stated that he had run to the bathroom and tried to keep Gutierrez from attacking him, but she pushed through the door. He stated that Gutierrez had punched him in the back of his head and had struck his eye. The Deputy observed signs of physical injury, including a puffy eye and scratches and red marks on his back and arms. The injuries were photographed. The Victim stated that Gutierrez had been trying to hurt him. He stated that he has been staying at Gutierrez's home for about one week and that they are friends. He also reported that a similar incident had happened the day before, but that he had not reported that incident to law enforcement.

Deputy Blakesley was allowed into the bedroom where Gutierrez had been sleeping. The bed was dry. There did not appear to be any vodka in the room. There was a mug that tipped over, but it appeared as though the mug had had water in it and there was water on the floor by the tipped mug. Gutierrez's eyes were normal in appearance and she had no injuries, except for her left wrist being swollen from punching the Victim.

Gutierrez was transported to New Ulm Detox and a warrant is requested.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
