The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 3rd Degree - Possess - Methamphet/Amphetamine in School/Park/Pub Housing Zone

Minnesota Statute: 152.023.2(a)(6), with reference to: 152.023.3(a)

Maximum Sentence: 20 years or \$250,000, or both

Offense Level: Felony

Offense Date (on or about): 04/01/2024

Control #(ICR#): 24008205

Charge Description: On or about April 1, 2024, in the County of Blue Earth, Minnesota, George Eugene Pepin did unlawfully possesses one or more mixtures containing methamphetamine or amphetamine in a school zone, a park zone, a public housing zone, or a drug treatment facility.

COUNT II

Charge: Fleeing a Peace Officer By a Means Other Than a Motor Vehicle

Minnesota Statute: 609.487.6

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 04/01/2024

Control #(ICR#): 24008205

Charge Description: On or about April 1, 2024, in the County of Blue Earth, Minnesota, George Eugene Pepin, did, for the purpose of avoiding arrest, detention, or investigation, attempted to evade or elude a peace officer who is acting in the lawful discharge of an official duty, by means of running, hiding or any other means other than fleeing in a motor vehicle.

STATEMENT OF PROBABLE CAUSE

On April 1, 2024, Officer Janak observed George Pepin (DOB 12/02/1989) in an affordable housing and park drug enforcement zone in Blue Earth county. Officer Janak was aware Pepin had a warrant for his arrest and he initiated his squad vehicle lights and sirens to summon Pepin to stop. Pepin, who was on a bicycle, then increased his speed and fled from Officer Janak before crashing. Pepin was taken into custody. Located on Pepin was a glass pipe with a white crystalline residue that field tested positive for methamphetamine.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
