COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Fugitive from Justice from Other State

Minnesota Statute: 629.13

Maximum Sentence: Rendition to the demanding State

Offense Level: Felony

Offense Date (on or about): 07/15/2024

Control #(ICR#): 24018985

Charge Description: On or about July 15, 2024 at 2:20 PM, in the County of Blue Earth, Minnesota, said defendant, Lonny James Telthoester is a fugitive from justice in that Lonny James Telthoester is present in Blue Earth County, Minnesota and have been charged with the commission of a crime in any other state and having fled from justice, or having been convicted of a crime in another state and having escaped from confinement, broken the terms of bail, probation, or parole, and the State of the rendition of the defendant for return to the State of Wisconsin has issued a warrant for the defendant's arrest and demanded the defendant's return.

STATEMENT OF PROBABLE CAUSE

Complainant makes complaint to the undersigned Judge of the above-named Court pursuant to Minnesota Statutes 629.13, 629.14, and 629.15 for Court determination of probable cause to support an Order of Detention for the above-named Defendant, as follows:

Complainant is a licensed peace officer for the State of Minnesota and is a Police Officer for the City of Mankato.

Complainant has received a teletype report, from the County of Portage, State of Wisconsin alleging that the above-named Defendant has committed a crime in said state and fled from justice.

The Defendant, Lonny James Telthoester (DOB 01/06/1966) was and is charged with Felony Failure to Register as a Predatory Offender. That said crime is punishable in said state by imprisonment of one year.

The Defendant is current in the custody of the State of Minnesota at the Blue Earth County Jail. The State of Wisconsin has confirmed that they will extradite the Defendant from Minnesota. The Portage County, Wisconsin Warrant was issued on June 24, 2024, and is body only and nationwide.

The Defendant is due to be Sentenced in Blue Earth County File 07-CR-23-4506 (Felony Check Forgery) on July 22, 2024 at 8:40 a.m. before Judge Mark Betters. A Pre-Sentence Investigation has been completed.
