**COMPLAINT**

Summons

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Drugs - 3rd Degree - Sale - Narcotic**

Minnesota Statute: 152.023.1(1), with reference to: 152.023.3(a)

Maximum Sentence: 20 years or \$250,000, or both

Offense Level: Felony

Offense Date (on or about): 07/28/2025

Control #(ICR#): 25021451

Charge Description: On or about July 28, 2025, in the County of Blue Earth, Minnesota, Mohamed Omar Ibrahim, did, unlawfully sell one or more mixtures containing a narcotic drug.

**COUNT II**

**Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp**

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/28/2025

Control #(ICR#): 25021451

Charge Description: On or about July 28, 2025, in the County of Blue Earth, Minnesota, Mohamed Omar Ibrahim, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe and said controlled substance was more than .25 grams or 1 dosage unit

## STATEMENT OF PROBABLE CAUSE

On July 28, 2025, agents with the Minnesota River Valley Drug Task Force (DTF) conducted a controlled purchase of cocaine utilizing a Confidential Reliable Informant (CRI). The controlled purchase occurred in the City of Mankato. The target was identified as Mohamed Omar Ibrahim. Ibrahim agreed to meet with the CRI and sell the CRI cocaine.

Agents met with the CRI before the controlled purchase and searched them for contraband. No contraband was located on their person. The CRI was provided with buy fund money and an electronic monitoring device. Agents drove the CRI near the purchase location and the CRI got out on foot.

The CRI and Ibrahim traded the buy fund money for the cocaine. The CRI then walked back to the meet location. The CRI got into Agent Jeff Fischbach's vehicle and provided Agent Fischbach with the cocaine and the electronic monitoring device.

The cocaine that the CRI purchased from Ibrahim on July 20, 2025, field-tested positive for the presence of cocaine. The cocaine was sent to the BCA where testing revealed that the cocaine weighed 1.864 g.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
