The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Threats of Violence-Reckless Disregard Risk

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/23/2026

Control #(ICR#): 26015906

Charge Description: On or about May 23, 2026, in the County of Blue Earth, Minnesota, Adrian Darren Dixon, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

STATEMENT OF PROBABLE CAUSE

On May 23, 2026, officers of the Mankato Department Public Safety were dispatched to a gas station report that an individual was threatening to stab people.

Officers arrived and made contact with Victim 1. Victim 1 said an individual, later identified as Adrian Darren Dixon, dob 03/27/1989, was threatening her. Specifically, Victim 1 said that Dixon made sexual remarks towards her. Dixon told Victim 1 not to go by him or he would stab and kill her. Dixon then started following Victim 1 to her vehicle and was reaching for something in his waistband.

Victim 1 expressed fear for her safety and believed Dixon had a knife which he would use to follow through on his threats.

A witness provided law enforcement with a video. In the video, Dixon is seen stating, "stay away from me... before y'all get stabbed to death...before I stab the fuck out of y'all."

Dixon was located on May 25, 2026. Dixon was wearing a fleece ski-style mask despite it being over 70 degrees out. In Dixon's pocket, officers located a silver steak knife.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
