COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault - 4th Degree - Peace Officer - Physically Assaults

Minnesota Statute: 609.2231.1(b)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 02/10/2026

Control #(ICR#): 26004147

Charge Description: On or about February 10, 2026, in the County of Blue Earth, Minnesota, Angela Quinne Harrison did physically assault a peace officer when that officer was effecting a lawful arrest or executing any other duty imposed by law.

Charge: Obstruct Legal Process-Lawful Execution Legal Process

Maximum Sentence: 364 days or \$3,000 fine, or both

Charge Description: On or about February 10, 2026, in the County of Blue Earth, Minnesota, Angela Quinne Harrison did and intentionally obstruct, hinder or prevent the lawful execution of any legal process or the apprehension of another on a charge or conviction of a criminal offense and the above act was accompanied by force or violence

STATEMENT OF PROBABLE CAUSE

On February 20, 2026, Officers were dispatched to a domestic within the city of Mankato located in the County of Blue Earth. The caller initially refused to provide information but was identified through prior contacts with her cell phone as Angela Quinne Harrison (11-03-1972). Harrison reported to dispatch that her husband had hit in her the face. Harrison hung up on the Dispatcher as they were trying to gather more information. Harrison then called back requesting the police.

Officer Calleigh Cogswell and Officer Kenden Slattery of the Mankato Department of Public Safety arrived on scene and made contact with Harrison. Harrison spoke with Officer Cogswell on the stairs leading to the upstairs of the residence due to refusing to speak anywhere else. Officer Cogswell observed a large knot to the top of her left cheek that was swollen with fresh blood. Harrison explained that she had been hit in the face with a remote control at close range by her husband.

Officer Slattery initially spoke with the husband who was later determined to be the initial aggressor regarding the domestic call. Officer Slattery then attempted to speak with Angela Harrison regarding her husband's cellphone. It was then determined necessary to conduct a limited protective sweep for officer safety. She immediately became confrontational at this time. Harrison was seated on the steps of the stairway which blocked access to the upstairs area that consisted of three bedrooms on the upper level. Officer Slattery attempted to walk up the stairs past Harrison; she then stood up and ran up the stairs to prevent officers from accessing the upper level. While upstairs she began shutting the doors to the bedrooms. Harrison then stood above Officer Slattery and proceeded to scream and yell directly in his face. Due to Harrison's aggression, Officers utilize physical control techniques to take her to the ground. During this time that she kicked Officer Slattery in the groin area and Officer Cogswell in the leg. She continued to actively resist by tensing her body, pulling her hands to front of her body despite repeated commands that she was under arrest. She refused to cooperate during the handcuffing process. Harrison was able to stand back up and continued to be uncooperative. Due to her behavior Officer Cogswell deployed a Taser utilizing the warning arc (Taser 10) to gain compliance.

Officer Christianson arrived on scene and with his assistance Officers were able to place Harrison into handcuffs and placed her in the back of a squad vehicle.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
