The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 09/21/2026

Control #(ICR#): 26030470

Charge Description: On or about September 21, 2026, in the County of Blue Earth, Minnesota, Coltyn Jay Hubbard, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except a small amount of marijuana, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe, after having been previously convicted of a violation of Chapter 152.

COUNT II

Charge: Cannabis open package - Possess in motor vehicle; Not compliant packaging or container

Minnesota Statute: 169A.36.3(1), with reference to: 169A.36.5

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 09/21/2026

Control #(ICR#): 26030470

Charge Description: On or about September 21, 2026, in the County of Blue Earth, Minnesota, Coltyn Jay Hubbard, had in possession while in a private motor vehicle on a street or highway, any cannabis flower, a cannabis product, a lower-potency hemp edible, a hemp-derived consumer product, or any other

product containing an artificially derived cannabinoid that is in packaging or another container that does not comply with the relevant packaging requirements in chapter 152 or 342.

STATEMENT OF PROBABLE CAUSE

In the evening on September 21, 2026, an Agent from the Minnesota River Valley Drug Task Force requested assistance with an individual observed in a vehicle who was known to have a felony warrant. Police had observed the male with a black backpack. After the driver of the vehicle failed to come to a complete stop at multiple stop signs and sped, Officer Whittet from the Mankato Department of Public Safety initiated a traffic stop.

Witness 1 was driving and Coltyn Jay Hubbard (DOB: 06/26/2001) was in the passenger seat. Hubbard had an active arrest warrant and was placed under arrest.

Officer Honetschlager searched Hubbard and found a THC vape with a small bag containing a green leafy substance that NIK-tested positive for marijuana and weighed 6.96 grams. Witness 1 told police a backpack in the backseat of the vehicle belonged to Hubbard. Officer Honetschlager searched it and discovered a magnetic storage box that contained a gem-style baggie with a white, crystal-like substance that field-tested positive for methamphetamine and weighed .24 grams.

Hubbard was convicted on May 19, 2025, of violating Minnesota Chapter 152, in Court File No. 07-CR-24-3249.

Hubbard is currently in a detoxification facility, and the State requests a warrant.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
