COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Carry BB Gun/Rifle/Shotgun/Aslt Wpn-Public Place

Minnesota Statute: 624.7181.2

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 03/22/2026

Control #(ICR#): 26008538

Charge Description: On or about March 22, 2026, in the County of Blue Earth, Minnesota, Isaac Mathias Sherman did carry a BB gun in a public place.

COUNT II

Charge: Cannabis open package - Possess in motor vehicle; Not compliant packaging or container

Minnesota Statute: 169A.36.3(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 03/22/2026

Control #(ICR#): 26008538

Charge Description: On or about March 22, 2026, in the County of Blue Earth, Minnesota, Isaac Mathias Sherman, did have in possession, while in a private motor vehicle on a street or highway, any cannabis flower, a cannabis product, a lower-potency hemp edible, a hemp-derived consumer product, or any other product containing an artificially derived cannabinoid that: is in packaging or another container that does not comply with the relevant packaging requirements in chapter 152 or 342.

COUNT III

Charge: Obstruct Legal Process-Interfere w/Peace Officer

Minnesota Statute: 609.50.1(2), with reference to: 609.50.2(3)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 03/22/2026

Control #(ICR#): 26008538

Charge Description: On or about March 22, 2026, in the County of Blue Earth, Minnesota, Isaac Mathias Sherman, did obstruct, resist, or interfere with a peace officer while the officer is engaged in the performance of official duties.

STATEMENT OF PROBABLE CAUSE

On March 22, 2026, at approximately 1:20 AM, Sergeant Price with the Mankato Department of Public Safety was on patrol in Mankato, Minnesota, Blue Earth County. Blue Earth County dispatch received a 911 call about a possible drunk driver. The caller provided a make and model of a pickup truck as well as license plate. The caller stated that the male was in a bar and trying to start a fight.

Sergeant Price observed the vehicle and initiated a traffic stop. The driver, who was later identified as Isaac Mathias Sherman (dob 01/05/2002), immediately got out of the vehicle and started approaching Sergeant Price. Sherman disregarded commands to stay back and aggressively approach Sergeant Price while yelling "fuck you." Eventually, Sherman agreed to sit next to a light pole. He was handcuffed.

Sergeant Price observed what appeared to be in uncased rifle in the back of Sherman's vehicle. Sergeant Price recovered the rifle and discovered it to be a BB gun. Sherman does not have a permit to carry.

Sherman was arrested. On his person, Sherman had THC wax that was in a clear glass container that doesn't comply with the open package laws.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
