COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-2nd Degree-Dangerous Weapon

Minnesota Statute: 609.222.1, with reference to: 609.222.1

Maximum Sentence: 7 years or \$14,000 fine or both.

Offense Level: Felony

Offense Date (on or about): 09/27/2026

Control #(ICR#): 26031100

Charge Description: On or about September 27, 2026, in the County of Blue Earth, Minnesota, Hector Antonio Carrillo, did assault another with a dangerous weapon.

COUNT II

Charge: Domestic Assault-Misdemeanor-Commits Act to Cause Fear of Immediate Bodily Harm or Death

Minnesota Statute: 609.2242.1(1), with reference to: 609.2242.1(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 09/27/2026

Control #(ICR#): 26031100

Charge Description: On or about September 27, 2026, in the County of Blue Earth, Minnesota, Hector Antonio Carrillo, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death.

STATEMENT OF PROBABLE CAUSE

On September 27, 2026, Officers of the Mankato Department of Public Safety responded to a residence in the City of Mankato in response to a domestic assault call.

Officer Whittet arrived and spoke with Victim 1. Officer Whittet observed fresh drops of blood on the doorway of the bathroom inside the residence. Victim 1 reported that she shares a child with Hector Antonio Carrillo (DOB: 07/31/1993). They have been working on their relationship since June, 2026. On September 27, 2026, Victim 1 rejected Carillo's sexual advances and Carillo became agitated. Carillo left the residence and went to the bar. Carillo returned to the apartment and began banging on her door. Victim 1 let Carillo into the apartment, but upon realizing how intoxicated he was, she locked herself into her bedroom.

Carillo grabbed a knife and began banging on the bedroom door. Carillo then used the knife to force the bedroom door open. When he entered the bedroom while holding the knife, he stated "I am going to kill myself and make you watch." A physical altercation ensued and Carillo then fell on top of Victim 1, while holding the knife. Carillo held Victim 1's wrist with the same hand in which he held the knife.

Victim 1 freed herself, ran to the bathroom, and locked the door. Victim 1 reported that she was afraid that she would be stabbed or cut by the knife.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
