The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Abuse No Contact Order - Violate No Contact Order - within 10 years of previous conviction

Minnesota Statute: 629.75.2(c)

Maximum Sentence: 10 days to 364 days or \$3,000 fine, or both.

Offense Level: Gross Misdemeanor

Offense Date (on or about): 01/17/2026

Control #(ICR#): 26001751

Charge Description: On or about January 17, 2026, in the County of Blue Earth, Minnesota, Chriscil Lionel Lukobi Johnson did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order and the violation occurred within ten years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency.

STATEMENT OF PROBABLE CAUSE

On January 17, 2026, Officer Colton Pike of Mankato Department of Public Safety was dispatched to a welfare check within the city of Mankato. Chriscil Lionel Lukobi-Johnson (DOB 12/21/1993) stated that he drove for an hour to do a "welfare" check concerning his children and their mother who is Victim in his report. Officer Pike searched both Victim and Luokobi-Johnson's names and observed that there is an active DANCO (Domestic Abuse No Contact Order); with Lukobi-Johnson as respondent and Victim as the protected person. The DANCO was issued under Court Case Number 07-CR-24-1108.

Approximately 30 minutes after Officer Pike was dispatched to a welfare check Victim called 911 reporting that her ex-husband Lokobi-Johnson showed up out of nowhere. Victim reported receiving calls from the front of her apartment complex, but she did not answer the calls. She then went to look outside and observed it to be Luokobi-Johnson. Victim indicated that the Luokobi-Johnson had left her two voicemails.

Officer Pike made contact with Luokobi-Johnson via phone. Luokobi-Johnson stated that he was at "Panther." Officer Pike believed this could mean Panther Lane within Mankato, but Luokobi-Johnson. Officer tried to obtain more information from Luokobi-Johnson but was unsuccessful. Law enforcement was unable to locate Luokobi-Johnson.

Officer Pike reviewed the DANCO order, and the DANCO order states "You may not go to the following location(s): [with no address listed] or wherever the protected person resides." In the Release order under file 07-CR-24-1108, it states: Stay a reasonable distance away from victim's residence, "No contact with victim(s); Direct or indirect, and "Domestic No Contact Order (DANCO)."

While conducting a criminal history search Officer Pike observed that Luokobi-Johnson has a criminal conviction of Harassment Restraining Order Violation (MN 609.748.6(a) from 11/20/2023.

Officer Pike made contact again, and Victim indicated that Luokobi-Johnson arrived unannounced at her residence again.

Due to Lukobi-Johnson's whereabouts being unknown at this time and his continuous attempts to contact victim on multiple occasions via phone or in person after speaking with law enforcement a Complaint Warrant is requested.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.

Complainant declares under penalty of perjury that everything stated in this document is true and correct. Minn. Stat. § 358.116; Minn. R. Crim. P. 2.01, subds. 1, 2.
