The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Theft-Take/Use/Transfer Movable Prop-No Consent

Minnesota Statute: 609.52.2(a)(1), with reference to: 609.52.3(3)(c)

Maximum Sentence: 5 years or \$10,000, or both

Offense Level: Felony

Offense Date (on or about): 08/11/2026

Control #(ICR#): 26025356

Charge Description: On or about August 11, 2026, in the County of Blue Earth, Minnesota, Cassandra Jane Gimmer, did intentionally aid, advise, hire, counsel, or conspire with, or otherwise procure another to commit the crime, and/or did personally commit said crime; to wit: intentionally and without claim of right take, use, transfer, conceal or retain possession of the movable property of another without the other's consent and with intent to deprive the owner permanently of possession of the property and the value of the property or services stolen is more than \$500 but not more than \$1,000 and the person has been convicted within the preceding five years for an offense under this section, section 256.98; 268.182; 609.24; 609.245; 609.53; 609.582, subdivision 1, 2, or 3; 609.625; 609.63; 609.631; or 609.821, or a statute from another state, the United States, or a foreign jurisdiction, in conformity with any of those sections, and the person received a felony or gross misdemeanor sentence for the offense.

STATEMENT OF PROBABLE CAUSE

On August 11, 2026, Officer Marzolf of the Mankato Department of Public Safety received a report of theft from Business 1, a store in the City of Mankato. Witness 1, an Asset Protection Investigator, reported that he observed Dustin Daniel Pierson (12/23/2000) and Cassandra Jane Gimmer (03/21/1986) steal a generator and other items worth more than \$500.00. They loaded the items into a White Chevy Avalanche. Gimmer was observed in the store placing items into a blue bag.

Officer Marzolf is familiar with Pierson and Gimmer. Officer Marzolf reviewed DVS records which showed that Gimmer owns an Avalanche bearing MN License Plate # FJD902.

Officer Marzolf located the Avalanche near Pierson and Gimmer's address. Officer Marzolf stopped the vehicle, located Pierson and Gimmer, and observed a generator in a sealed box in the back of the truck.

Officer Marzolf arrested Pierson. Officer Honetschlager took Gimmer into custody. Officers searched the vehicle and located an uncased, realistic-looking BB gun under the passenger seat, apparent stolen items in a blue bag, and the generator.

Officer Marzolf read Pierson the *Miranda* warning. Pierson agreed to speak and told Officer Marzolf that he had stolen the generator. Pierson also acknowledged that he kept the BB gun in in the car.

Officers returned the recovered items to Business 1. Officers learned the total value of the stolen merchandise was \$761.18.

On April 7, 2026, Gimmer was convicted of Gross Misdemeanor Theft in Court File # 08-CR-25-866.
