The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 02/07/2026

Control #(ICR#): 26003781

Charge Description: On or about February 7, 2026, in the County of Blue Earth, Minnesota, Marcus Juvon Collins, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe, and the person possesses more than one dosage unit if the substance is packaged in dosage units.

COUNT II

Charge: Theft-Take/Use/Transfer Movable Prop-No Consent

Minnesota Statute: 609.52.2(a)(1), with reference to: 609.52.3(4)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 02/06/2026

Control #(ICR#): 26003781

Charge Description: On or about February 6, 2026, in the County of Blue Earth, Minnesota, Marcus Juvon Collins did, intentionally and without claim of right take, use, transfer, conceal or retain possession of the movable property of another without the other's consent and with intent to deprive the owner permanently

of possession of the property and the value of the property or services stolen exceeded \$500.00 but was less than \$1,000.00.

STATEMENT OF PROBABLE CAUSE

On February 6, 2026, at approximately 6:42 PM, Ofc. Colton Pike with Mankato Department of Public Safety was dispatched to a pet store in the City of Mankato on a shoplifting complaint. The complainant, Witness 1, an employee of the store, reported that a theft had occurred there approximately an hour prior and the suspect, who would later be identified as Marcus Juvon Collins, had left in a vehicle bearing Minnesota license plate HPC 084, a blue Dodge Journey.

Ofc. Pike made contact with Witness 1 who provided a description of Collins. Witness 1 provided photographs of the items stolen by Collins. They included pet items for dogs totaling over \$500.

Through further investigation, Ofc. Pike learned that the Dodge Journey was at a residence on Homestead Road in the City of Mankato.

On February 7, 2026, Ofc. Pike went to the residence and located the vehicle as well Collins. Ofc. Pike placed Collins in handcuffs and conducted a search incident to arrest. While conducting the search, Ofc. Pike found three loose pills in Collins's front pocket. The pills would later field test positive for the presence of MDMA. MDMA is a Schedule I controlled substance.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
