COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault-GM-Subsequent Violation

Minnesota Statute: 609.2242.2

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 09/14/2026

Control #(ICR#): 26029679

Charge Description: On or about September 14, 2026, in the County of Blue Earth, Minnesota, Angelee Marie Hayden, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another and has a previous qualified domestic violence-related offense conviction or an adjudication of delinquency within ten years.

STATEMENT OF PROBABLE CAUSE

In the evening on September 14, 2026, Officers from the Mankato Department of Public Safety responded to the Emergency Room at Business 1 after Victim 1 reported she was assaulted by her sister, Angelee Marie Hayden (DOB: 09/08/2003).

Officer Christianson spoke with Hayden who said she got in an argument with Victim 1 earlier that day about Hayden's child. While Hayden was at the top of a staircase and Victim 1 was at the bottom, at Hayden's residence in Blue Earth County, Hayden threw Hayden's phone at Victim 1. Hayden claimed not to know whether the phone hit Victim 1.

Victim 1 spoke with Officer Wright and said she and Hayden got in an argument earlier about Hayden's children. Victim 1 reported that while she was at the bottom of a staircase and Hayden was at the top, Hayden threw an object at Victim 1 that struck Victim 1 in the head and felt heavy. Victim 1 immediately noticed blood coming from the area where she was struck, and she became dizzy as a result of the strike. Victim 1 went to the hospital where she received three stitches for a laceration on her forehead.

Officer Wright also spoke with Witness 1, the mother of Hayden and Victim 1, who was present for the incident. Witness 1 reported Hayden kept telling Victim 1 that Hayden wanted to fight. Witness 1 saw Hayden throw an object at Victim 1 that hit Victim 1 in the head. Witness 1 believed it was Hayden's cell phone. Witness 1 observed Victim 1 bleeding because of the item that hit her.

Hayden was adjudicated delinquent on September 23, 2020, for an Assault-5th Degree offense, in Court File No. 07-JV-19-4788.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
