The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Theft-Theft of motor fuel from retailer**

## **STATEMENT OF PROBABLE CAUSE**

On January 20, 2026, Officer Travis Bottelson of Lake Crystal Police Department contacted Witness 1 of Business 1 that is located within Blue Earth County regarding reports of past gas drive-offs that involved an older light blue pickup truck bearing Minnesota license plate FLJ045. The older blue truck's driver would pump gas from Business 1 and drive away without paying. These incidents occurred on 1/14/2026, 1/17/2026, and 1/19/2026. Witness 1 described the driver as a larger male in his early to mid-twenties. Officer Bottelson then ran the aforementioned license plate number through the state system and observed the vehicle to be registered to Cameron Po Lorentz (DOB 7/12/2006). Officer Bottelson also observed the registered owner of the vehicle appeared to match the description provided by Witness 1.

While receiving the complaint from Business 1 Officer Bottelson heard via his radio a traffic stop being conducted by Mankato Department of Public Safety. The vehicle stopped by Mankato Department of Public Safety was being driven by Lorentz and had the same license plate of FLJ045.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
