The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/25/2026

Control #(ICR#): 26023331

Charge Description: On or about July 25, 2026, in the County of Blue Earth, Minnesota, Robert Lacomere Singleton, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except a small amount of marijuana, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe, after having been previously convicted of a violation of Chapter 152.

COUNT II

Charge: Threats of Violence-Reckless Disregard Risk

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/25/2026

Control #(ICR#): 26023331

Charge Description: On or about July 25, 2026, in the County of Blue Earth, Minnesota, Robert Lacomere Singleton, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

COUNT IV

Charge: Obstruct Legal Process-Interfere w/Peace Officer

Minnesota Statute: 609.50.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 07/25/2026

Control #(ICR#): 26023331

Charge Description: On or about July 25, 2026, in the County of Blue Earth, Minnesota, Robert Lacomer Singleton, did obstruct, resist, or interfere with a peace officer while the officer is engaged in the performance of official duties.

STATEMENT OF PROBABLE CAUSE

On July 25, 2026, Officer Aaron Gelle observed Robert Singleton (DOB: 1/21/1981) sitting on the patio of Business 1 in the City of Mankato with Blue Earth County, law enforcement Officers of the Mankato Department of Public Safety observed Singleton have Modelo which is a beer/alcoholic beverage. Due to previous calls for services Officer Gelle was aware that Singleton is under no use conditions for his release from jail.

Officer Gelle informed Officer Brianna Wagner of this and both Officers approached Singleton and advised him that he knew he was not supposed to be drinking alcohol and he responded, "I just had a baby today, I'm celebrating." He was informed of the violation and that he was being placed under arrest for the offense. Singleton then took another drink of the beer. He was then placed into handcuffs.

While being escorted to the patrol vehicle he continually yelled obscenities as the Officers. He then started to throw his elbow and continued to resist. Officer Gelle conducted a search on Singleton. He started screaming how this was an illegal search, an illegal arrest and that he needed his rights read to him. He was placed in the back of the patrol vehicle and began making spitting sounds. Singleton was incredibly uncooperative by moving his body and head towards Officer Gelle. Singleton kept calling Officer Gelle names and obscenities and would not allow a seat beat to be placed on him. Singleton made an attempt to headbutt and physically assault Officer Gelle.

Singleton was eventually seat belted and transported to the Blue Earth County Jail. While en route to jail Singleton made numerous threats and comments about how he would fuck Officer Gelle up when the handcuffs come off. "When we get to the jail make sure you're close so I can get you. Due to the behavior Singleton had displaced since being approached by law enforcement Officer Gelle did believe Singleton's goal was to Assault him. Singleton continuously spit all over the patrol vehicle.

Upon walking into the jail Singleton dropped a baggy of suspected drugs. Officer Gelle took custody of the baggy and Officer Gelle observed the contents of the baggy to have a white powdery substance. The baggy and contents were tested. The tests resulted in a presumption test for Methamphetamine and weighed .064 grams.

While reviewing footage of the arrest and Singleton in the backseat of the patrol vehicle. Officer Gelle observed Singleton go to his waist band and held something in his hands. Officer Gelle believed this to be the baggy of Methamphetamine.
