The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault - By Strangulation

Minnesota Statute: 609.2247.2, with reference to: 609.2247.2

Maximum Sentence: 3 years or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 04/19/2025

Charge Description: On or about April 19, 2025, in the County of Blue Earth, Minnesota, Anderson Thermidor did assault a family or household member by strangulation.

COUNT II

Charge: Emergency Telephone Calls/Communications - Interrupt, Interfere, Impede, Disrupt 911 Call

Charge: Domestic Assault-Misdemeanor-Intentionally Inflicts/Attempts to Inflict Bodily Harm on Another

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Charge Description: On or about April 19, 2025 at 8:00 PM, in the County of Blue Earth, Minnesota, Anderson Thermidor, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another.

STATEMENT OF PROBABLE CAUSE

On April 19, 2024, at 8:49 p.m. officers from the Mankato Department of Public Safety were dispatched to a domestic that resulted in the victim being transported to a hospital by ambulance.

Officers met with Victim 1 at their residence. They reported that Anderson Thermidor (12/03/1989) had put his hands around her throat and choked her so she could not breath. Officers also noted visible injuries on her upper chest and photographs were taken.

Victim 1 and Thermidor were in a relationship and living together. Earlier in the day, she was working on the laundry when Anderson arrived home. Anderson has been getting more aggressive with Victim 1. Today he hit her, scratched her, choked her and kicked her multiple times in an area where she had had two previous surgeries. Thermidor is aware of those surgeries and the extra sensitivity of that area.

Thermidor grabbed Victim 1 and threw her on the floor where she hit her head. Victim 1 was scared for her life and felt like he was going to kill her. When Victim 1 was able to call 9-1-1, Thermidor first tried to grab the phone out of her hands, leaving marks on her hand. When Victim 1 connected with 911, Thermidor ran away leaving his phone behind.

The Defendant is subject to two separate DANCOs with two separate females stemming from 07-CR-24-2131 where in the Thermidor is charged with two counts of Domestic Assault in a Mankato City case. Thermador failed to appear at a court appearance on October 3, 2024 and the warrant was outstanding until October 14, 2024.

Law enforcement believes that Thermador is an active danger to Victim 1 and others and a Complaint Warrant is requested.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
