The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Domestic Assault-GM-Subsequent Violation

Minnesota Statute: 609.2242.2

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 09/01/2024

Control #(ICR#): 24024080

Charge Description: On or about September 1, 2024, in the County of Blue Earth, Minnesota, Dawayne Leeatras Billups did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death and has a previous qualified domestic violence-related offense conviction or an adjudication of delinquency within ten years.

STATEMENT OF PROBABLE CAUSE

On September 1, 2024, Officer Jessica Ellis and Officer Dylan McCarville of the Mankato Department of Public Safety were dispatched to Address 1 for domestic disturbance. Address 1 is located in Mankato, Blue Earth County. The caller, Victim, reported that her adult son was yelling and disrespecting her. As Dispatch was giving out the call, Victim reported her son had left the property in a black car with Wisconsin plates. Upon arrival, Victim reported that her son, Dawayne Leeatras Billups (DOB 1/3/96) picked up two canned goods, while in close proximity to Victim, and said "you want one?" or "let's go" to Victim. Victim showed Officer Ellis how Billups was standing, with closed fists and pushing his chest up.

In speaking with Victim, she believed she was going to be assaulted, either by being hit with the canned good or have the canned good thrown at her. Billups also told Victim that he was going to kill Victim in the heat of the moment, which she expressed put her in fear and believed Billups was capable of. Victim knew she was defenseless against Billups, because of his size and temper, so Victim decided to remove herself from the situation. Victim also stated that she called her boyfriend, Witness 1, to assist her with getting Billups off the property.

A review of Billups's criminal history shows a domestic-violence-related-offense conviction in file 19BU-CR02303 on 1/24/2020, from St Joseph, Missouri.
