COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault in the fifth degree; Gross misdemeanor-Within three years of previous conviction.

Minnesota Statute: 609.224.2(b), with reference to: 609.224.2(b)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 08/30/2025

Control #(ICR#): 25024774

Charge Description: On or about August 30, 2025 at 12:15 AM, in the County of Blue Earth, Minnesota, Omar Emir Sanchez, did intentionally inflict or attempt to inflict bodily harm upon another within three years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency.

COUNT II

Charge: Disorderly Conduct

Minnesota Statute: 609.72.1, with reference to: 609.72.1

Maximum Sentence: 90 days and/or \$1,000.00 fine

Offense Level: Misdemeanor

Offense Date (on or about): 08/30/2025

Control #(ICR#): 25024774

Charge Description: On or about August 30, 2025 at 12:15 AM, in the County of Blue Earth, Minnesota, Omar Emir Sanchez, did, in a public or private place, knowing, or having reasonable grounds to know it will, or will tend to, alarm, anger or disturb others or provoke an assault or breach of the peace, engaged in brawling or fighting

STATEMENT OF PROBABLE CAUSE

On August 31, 2025, at approximately 12:55 a.m., officers from the Mankato Department of Public Safety were dispatched to investigate a possible stabbing.

Investigation and CCTV revealed that witnesses observed Omar Emir Sanchez (07/26/1995) interacting with a person. Witnesses became concerned about Sanchez's behavior with a female. After a verbal exchange, Sanchez walked to and was about to get into a UBER when Sanchez turned around and approached Victim 1. Sanchez attacked Victim 1 and punched Victim 1 twice on the neck. Officers noted bruises on Victim 1's neck consistent with the attack..

Bystanders intervened to stop Sanchez and get him away from Victim 1. They managed to get Sanchez onto the ground. During the altercation, a person stabbed Sanchez. A doctor at the ER described Sanchez's injuries as "superficial" stab wounds.

Sanchez was released from the ER and arrested for an outstanding warrant in Blue Earth County District Court file 07-CR-23-3063. In that file Sanchez was convicted of Misdemeanor Violation of a Harassment Restraining Order on August 30, 2024. A probation violation warrant had been issued on June 20, 2025, and remained outstanding at the time of the arrest.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
