The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Fleeing a Peace Officer in a Motor Vehicle

Minnesota Statute: 609.487.3

Maximum Sentence: 3 years and one day or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 12/15/2025

Control #(ICR#): 25035744

Charge Description: On or about December 15, 2025, in the County of Blue Earth, Minnesota, Kangah Marc Badou did by means of a motor vehicle, flee or attempt to flee a peace officer who is acting in the lawful discharge of an official duty, and the perpetrator knows or should reasonably know the same to be a peace officer.

COUNT II

Charge: Traffic - Drivers License - Driving After Revocation

Minnesota Statute: 171.24.2(a)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 12/15/2025

Control #(ICR#): 25035744

Charge Description: On or about December 15, 2025, in the County of Blue Earth, Minnesota, Kangah Marc Badou did after being given notice, or reasonably should have known of the revocation, disobeyed the order by operating in this state any motor vehicle, the operation of which requires a driver's license, while her/his license or privilege was revoked.

COUNT III

Charge: Traffic - Reckless driving; Drives Consciously Disregarding a Substantial or Unjustifiable Risk

Minnesota Statute: 169.13.1(a), with reference to: 169.13.1(c)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 12/15/2025

Control #(ICR#): 25035744

Charge Description: On or about December 15, 2025, in the County of Blue Earth, Minnesota, Kangah Marc Badou, did drive any vehicle or light rail transit vehicle while aware of and consciously disregarding a substantial and unjustifiable risk that the driving may result in harm to another or another's property and that risk was of such a nature and degree that disregard of it constituted a significant deviation from the standard of conduct that a reasonable person would observe in the situation.

COUNT IV

Charge: Traffic - Speeding - Exceed Limit

Minnesota Statute: 169.14.2(a)
Maximum Sentence: \$300 fine
Offense Level: Petty Misdemeanor

Offense Date (on or about): 12/15/2025

Control #(ICR#): 25035744

Charge Description: On or about December 15, 2025, in the County of Blue Earth, Minnesota, Kangah Marc Badou did drive 53 miles per hour in an area with signs erected designating the speed limit as 30 miles per hour.

STATEMENT OF PROBABLE CAUSE

Late in the evening on December 15, 2025, Officer Hermanson from the Mankato Department of Public Safety was traveling northbound on Riverfront Drive from Highway 169 when he observed a vehicle traveling southbound at a high rate of speed. Hermanson activated his front-facing radar and registered a speed of 53 mph in the 30-mph zone. Hermanson activated his emergency lights and began to pursue the vehicle, which then entered the onramp to southbound Highway 169 from Riverfront Drive. Hermanson watched the vehicle overtake two other vehicles while traveling southbound on 169. Hermanson activated his siren and accelerated to catch up.

The vehicle continued southbound at a high rate of speed before entering the left-turn lane on it approach to the intersection with South Hawley Road. At the intersection, the vehicle appeared to lose control and entered opposing traffic lanes, traveling southbound in northbound lanes. Hermanson saw snow flying from the vehicle as it crossed the median. When the vehicle came to a stop, Hermanson noted it had travelled approximately 250 yards in opposing traffic lanes.

Hermanson and his Field Training Officer Honetschlager exited their squad car and drew their firearms, based on the conduct they had observed. Hermanson reported the pursuit had covered approximately one mile from the point where he activated his emergency lights to where the driver stopped the vehicle. The driver was identified as Kangah Marc Badou (DOB: 11/11/2003).

Hermanson found Badou's driver's licenses status was revoked after Badou was convicted on July 13, 2025, in Court File No. 52-VB-25-1519, for driving more than 100 miles per hour.

Incident to arrest, Hermanson search Badou's vehicle and found an unlocked cell phone with a text message thread open and a message from Badou that read in French, "The police arrested me, baby."

Badou acknowledged seeing Hermanson's emergency lights but said he thought Hermanson was trying to stop a different vehicle.

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
