The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 - Not Small Amount Marijuana (Felony)

Minnesota Statute: 152.025.2(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 09/12/2023

Control #(ICR#): 23023193

Charge Description: On or about September 12, 2023, in the County of Blue Earth, Minnesota, James Anthony Vanryn did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except a small amount of marijuana and the weight of the substance is greater than .25 grams or 1 dosage unit.

STATEMENT OF PROBABLE CAUSE

On September 21, 2023, The Minnesota River Valley Drug Task force executed a search warrant at a residence located in Blue Earth County. Agents knew James Anthony Van Ryn (1/9/1969) to live at the residence. Inside the residence, Agents located a digital scale, unused gem bags, and Van Ryn's driver license on a table in the living room. Agents also located two bags which contained a crystal-like substance. The crystal-like substance field tested positive for the presence of methamphetamine and weight 5.4 grams. Agents submitted the crystal-like substance to the Minnesota Bureau of Criminal Apprehension for testing. On October 23, 2023, the BCA lab results indicated the crystal-like substance tested positive for the presence of methamphetamine.

At this time Van Ryn's location and current address are unknown therefore the State is requesting a complaint warrant.

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
