The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Traffic Regulation - School Bus - Fail to Stop**

Minnesota Statute: 169.444.2(a)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 10/08/2025

Control #(ICR#): 26000031

Charge Description: On or about October 8, 2025, in the County of Blue Earth, Minnesota, Nicolaza Jennifer Kerns, failed to stop a vehicle or to keep it stopped, at least 20 feet away from a bus displaying an extended stop-signal arm and flashing red lights is guilty of a misdemeanor.

## STATEMENT OF PROBABLE CAUSE

On January 8, 2026, Officer Joyce Baker was notified by Palmer Bus Service of School Bus Arm Violation. Palmer Bus Service supplied video of the violation and a screen shot of the vehicle's license plate. Officer Baker reviewed video and observed that at 15:16:42 The School Bus Stop arm is fully extended, and children begin exiting the bus. Officer Baker also observed that at 15:17:08 Vehicle drives by the stop arm while numerous children are outside of the bus and continuing to exit the bus. The vehicle reported and depicted in the video was a gray Toyota Camry with a license plate of EAG874. Through her investigation Officer Baker discovered the owner to be Nicolozza Kerns regarding the violation. Kerns stated that she was driving and did not notice the bus. She did not notice the stop arm out, and by the time she did notice it was too late.

The school bus driver Witness 1 called the Mapleton Police Department to report the violation that he had witnessed. He stated that there were two girls about cross the street when he saw the vehicle coming towards them. He honked his horn several times to get the two girls' attention so they would not be hit by the vehicle as it passed the bus through the traffic where they were trying to cross.
