COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-2nd Degree-Dangerous Weapon

Minnesota Statute: 609.222.1, with reference to: 609.11.5(a)

Maximum Sentence: 7 years or \$14,000 fine or both.

Offense Level: Felony

Offense Date (on or about): 05/27/2024

Control #(ICR#): 24013719

Charge Description: On or about May 27, 2024, in the County of Blue Earth, Minnesota, Dante Dwayne Overton, did assault another with a dangerous weapon; to wit, a firearm.

COUNT II

Charge: Threats of Violence-Reckless Disregard Risk

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/27/2024

Control #(ICR#): 24013719

Charge Description: On or about May 27, 2024, in the County of Blue Earth, Minnesota, Dante Dwayne Overton, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

COUNT III

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/27/2024

Control #(ICR#): 24013719

Charge Description: On or about May 27, 2024, in the County of Blue Earth, Minnesota, Dante Dwayne Overton did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and said controlled substance was more than .25 grams or 1 dosage unit.

STATEMENT OF PROBABLE CAUSE

On May 27, 2024, officers of Mankato Department of Public Safety were dispatched to a disturbance that occurred in Blue Earth County Minnesota.

Officer Strong spoke with Victim 1. Victim 1 stated that there was a verbal argument and Dante Dwayne Overton brandished a pistol. Victim 1 said Overton cocked the handgun and was waving it around stating, "I am going to pop everyone in here." At one point Overton pointed the gun at Victim 1.

Witness 1 confirmed what Victim 1 said: that Overton threatened Victim 1 with a firearm.

Other officers observed Overton attempting to leave the scene and detained him. A search of Overton's person was conducted, and officers found 16 pink pills with an M and a square imprinted around. These pills are consistent with oxycodone and/or counterfeit pills that contain fentanyl.

A search warrant was obtained for the residence. A loaded Glock 23c handgun was recovered.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
