The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Fleeing a Peace Officer in a Motor Vehicle

Minnesota Statute: 609.487.3

Maximum Sentence: 3 years and one day or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 06/30/2025

Control #(ICR#): 25018577

Charge Description: On or about June 30, 2025, in the County of Blue Earth, Minnesota, Norah Rae Cahill did by means of a motor vehicle, flee or attempt to flee a peace officer who is acting in the lawful discharge of an official duty, and the perpetrator knows or should reasonably know the same to be a peace officer.

COUNT II

Charge: Traffic Regulations - Failure to obey traffic control device

Minnesota Statute: 169.06.4(a)
Maximum Sentence: \$300 fine
Offense Level: Petty Misdemeanor

Charge Description: On or about June 30, 2025, in the County of Blue Earth, Minnesota, Norah Rae Cahill did, as the driver of any motor vehicle, fail to obey the instructions of any official traffic-control device.

COUNT III

Charge: Cannabis open package - Possess in motor vehicle; Not compliant packaging or container

Minnesota Statute: 169A.36.3(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 06/30/2025

Control #(ICR#): 25018577

Charge Description: On or about June 30, 2025, in the County of Blue Earth, Minnesota, Norah Rae Cahill, did have in possession, while in a private motor vehicle on a street or highway, any cannabis flower, a cannabis product, a lower-potency hemp edible, a hemp-derived consumer product, or any other product containing an artificially derived cannabinoid that: is in packaging or another container that does not comply with the relevant packaging requirements in chapter 152 or 342.

STATEMENT OF PROBABLE CAUSE

Just after midnight on June 30, 2025, Officer Johnson of the Mankato Department of Public Safety was on patrol in Mankato, Minnesota. Officer Johnson observed a group of approximately six individuals who were sitting on what appeared to be motorized off-road motorcycles. Officer Johnson observed individuals actively using the vehicles on the sidewalk.

Officer Johnson turned around and observed the individuals take off and run through a red light. Officer Johnson activated his full emergency lights. The vehicles fled.

While fleeing, one individual crashed their motorcycle. The individual then attempted to get back on the motorcycle to flee. Officer Johnson got out of his car and physically apprehended the individual before she could further flee. The individual was identified as Norah Rae Cahill (DOB 8/2/2001). Cahill was arrested. Cahill has a bag of suspected marijuana in her cargo pocket of her pants. The marijuana was not in proper packaging.
