COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 09/22/2026

Control #(ICR#): 26019876

Charge Description: On or about September 22, 2026, in the County of Blue Earth, Minnesota, Dylan James Buhr, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and the mixture does not include any amount of a controlled substance in a fluid used in a water pipe and said controlled substance was more than .25 grams or 1 dosage unit.

COUNT II

Charge: Fleeing a Peace Officer By a Means Other Than a Motor Vehicle

Minnesota Statute: 609.487.6

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 09/22/2026

Control #(ICR#): 26019876

Charge Description: On or about September 22, 2026 at 9:58 PM, in the County of Blue Earth, Minnesota, Dylan James Buhr, did, for the purpose of avoiding arrest, detention, or investigation, attempted to evade or elude a peace officer who is acting in the lawful discharge of an official duty, by means of running,

hiding or any other means other than fleeing in a motor vehicle.

STATEMENT OF PROBABLE CAUSE

On September 22, 2026, deputies of the Blue Earth County Sheriff's Office were dispatched to a residence in Blue Earth County. It was reported that there was a domestic argument and Dylan James Buhr, dob 4/15/1991, was refusing to leave the premise. Deputies were aware that Buhr had multiple active warrants for his arrest.

Deputies arrived in the area. Buhr fled on foot. Deputies lost contact with Buhr and then later observed him down a ravine into the woods. Deputies commanded Buhr to stop, but he fled again. Eventually, after approximately .25 miles, Buhr was apprehended by a Mankato Police Officer.

Buhr refused to comply with commands to get on the ground and put his hands behind his back. Buhr kept reaching into his pockets. Eventually, law enforcement took control of Buhr and placed him under arrest. Buhr made a comment that he wanted to turn himself in but was addicted to fentanyl.

Deputies observed multiple blue pills consistent with m-box pills that contain fentanyl near Buhr. The pills dissolved in a puddle. Deputies also found two knives that Buhr had threw off his person and a clear Ziplock bag with a white crystal substance that tested positive for methamphetamine and weighed approximately 0.5 grams.

Buhr has a prior Chapter 152 conviction in 07-CR-14-3104.
