The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Threats of Violence-Reckless Disregard Risk

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 02/06/2026

Control #(ICR#): 26002440

Charge Description: On or about February 6, 2026, in the County of Blue Earth, Minnesota, Christopher Allen Karloske, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

COUNT II

Charge: Threats of Violence-Reckless Disregard Risk

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 02/06/2026

Charge Description: On or about February 6, 2026, in the County of Blue Earth, Minnesota, Christopher Allen Karloske, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

STATEMENT OF PROBABLE CAUSE

On February 6, 2026, at approximately 2:11 PM, Deputy Brian Baumann, with the Blue Earth County Sheriff's Office, was at the hospital in the City of Mankato assisting in supervising an inmate that was receiving medical attention. The inmate was identified as Christopher Allen Karloske. Also present was Corrections Officer (CO) Jovan Rodriguez.

Karloske had awoken from a nap and began communicating with the Patient Care Assistant (PCA) about using the restroom. Karloske became upset, agitated, and raised his voice. Karloske was in leg restraints at the time; no other restraints are being used.

Karloske spit across the room, not directly at anyone. The spit hit the wall. Karloske then threw a pillow across the wall. Hospital security was summoned and arrived shortly thereafter.

CO Rodriguez advised Karloske to not throw things. Karloske responded to Rodriguez stating, "I will throw whatever I want, bitch, bitch, bitch, pussy ass n****." PCA Victim 1 told Karloske to knock it off. Karloske replied, "no, fuck that shit, I told you to get this n**** out of my room 10 years ago," and, "wait until I get out this, I'm going to turn this hospital way the fuck up." Karloske then continued to call staff, "fat ass bitches," "cunts," and "fat ass whores."

Karloske then turned his attention to Deputy Baumann. Karloske stated, "I don't know why you're standing there pussy ass bitch, take one of those clips, load it and fucking off you, hoe."

Karloske kept staring at Deputy Baumann and stated, "I'll slap you and your mom stupid, fucking bitch. Fucking faggot." Karloske then stated, "Oh I got a gun, I'm cool, no you're a fucking faggot. Fucking put it to your brain and flocking pop, then press on your face." Karloske said this while making a motion with his hand up putting a gun to his head and making a pop noise. Karloske then stated, "I'm going to fuck this hospital up when I get out of here, I'm going to come back and fuck this bitch up."

Deputy Baumann told Karloske that he cannot threaten to kill people. Karloske replied, stating, "you do it every day." Karloske then stated, "I wish I did, I wish I knew where you lived."

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
