The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Violate No Contact Order - Within 10 years of the first of two or more convictions

Minnesota Statute: 629.75.2(d)(1)

Maximum Sentence: 30 days to 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 12/05/2025

Control #(ICR#): 25034850

Charge Description: On or about December 5, 2025, in the County of Blue Earth, Minnesota, Tyreese Albert Johnson did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order and the violation within ten years of the first of two or more previous qualified domestic violence-related offense convictions or adjudications of delinquency.

STATEMENT OF PROBABLE CAUSE

On December 5, 2025, The Honorable Bradley C. Walker, Judge of District Court, issued a Domestic Abuse No Contact Order (“DANCO”) in Court File No. 07-CR-25-4926, listing Tyreese Albert Johnson (DOB: 04/17/1993) as Defendant and Victim 1 as the Protected Person. The DANCO prohibits Johnson from having “contact directly, indirectly or through others, in person, by telephone, in writing, electronically or by any other means with [Victim 1].” Johnson was served with a copy of the DANCO that same day.

A few hours later, Johnson was still in custody at the Blue Earth County Jail in connection with Court File No. 07-CR-25-4926. While Johnson was in the process of being released from the jail, Johnson informed Witness 1, a Corrections Officer, that Victim 1 had a new phone number, Phone Number 1. Witness 1 contacted Victim 1 at Phone Number 1 and informed Victim 1 that Johnson was about to be released from jail. Witness 1 later discovered that Johnson had called the same phone number on the recorded jail phone line.

Officer Hermanson reviewed records of Johnson’s communication while in the Blue Earth County Jail and noted 28 phone calls to Phone Number 1, and numerous text messages with Phone Number 1, after being served with the DANCO.

Victim 1 advised Witness 2 Victim 1 had been in contact with Johnson, by phone and by text message, throughout the day. Victim 1 told Witness 2 Victim 1 did not know about the DANCO in place.

Johnson has the following convictions for qualified domestic violence-related offenses: (1) Domestic Assault – Court File No. 07-CR-23-2199 – June 18, 2024; (2) DANCO Violation – Court File No. 74-CR-19-1695 – December 2, 2019; (3) DANCO Violation – Court File No. 74-CR-19-1165 – October 7, 2019; (4) Domestic Assault – Court File No. 74-CR-19-940 – October 7, 2019; (5) Threats of Violence – Court File No. 74-CR-17-2151 – February 14, 2018; and (6) Emergency Telephone Call-Interrupt – Court File No. 74-CR-17-2151 – February 14, 2018.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
