The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Damage to Property - 3rd Degree - Reduce Value \$501-\$1000

Minnesota Statute: 609.595.2(a)(1)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 06/27/2026

Control #(ICR#): 26019956

Charge Description: On or about June 27, 2026, in the County of Blue Earth, Minnesota, Dolph Samuel Struck did intentionally cause damage to another person's physical property without the other person's consent, and the damage reduced the value of the property by more than \$500.00 but no more than \$1,000.00 as measured by the cost of repair and replacement.

STATEMENT OF PROBABLE CAUSE

On June 27, 2026, officers from the Mankato Department of Public Safety responded to complaints of criminal damage to property within the City of Mankato. Officer Sokolov spoke with Witness 1 who stated that an individual (later identified as Dolph Samuel Struck DOB: 04/26/1995) had smashed the rear window of a white PT Cruiser vehicle with a smaller circular object.

Witness 1 provided Officer Sokolov with a description of the suspect and informed him that Struck had smashed two of the vehicles' windows. Officer Sokolov arrived at the location where the vehicle was parked and noted that the driver's door window and driver side rear passenger window had been smashed.

Officer Sokolov spoke with Victim 1 who stated that there did not appear to be anything missing from the vehicle. Victim 1 also noted that the total estimated damage was \$500.

Later on June 27th, Officers also responded to reports of criminal damage to a different vehicle within the City of Mankato where it was suspected that Struck was involved. Officers reviewed surveillance footage and confirmed that Struck was the individual damaging vehicles in this incident. Struck threw rocks at a vehicle, causing approximately \$500 in damage to the vehicle.

The total property damage caused by Struck is currently estimated at \$1,000.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
