**COMPLAINT**

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Drugs - Aggravated Controlled Substance Crime 1st Degree and 2 aggravating factors**

Minnesota Statute: 152.021.2b(2), with reference to: 152.021.3(d)

Maximum Sentence: 40 years or \$1,000,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/08/2026 to 09/08/2026

Control #(ICR#): 26024541

Charge Description: On or between July 8, 2026 and September 8, 2026, in the County of Blue Earth, Minnesota, Andi Tirana Selenica did, within a 90 day period, unlawfully sell one or more mixtures of a total weight of 50 grams or more containing amphetamine, phencyclidine, or hallucinogen or, if the controlled substance is packaged in dosage units, equaling 200 or more dosage units; and the defendant or an accomplice sells or possesses 100 or more grams or 500 or more dosage units of a mixture containing the controlled substance at issue and the offense involves two aggravating factors.

**COUNT II**

**Charge: Drugs - 1st Degree - Sale - 50 grams or 200 dose units - amphetamine, phencyclidine, hallucinogen**

Minnesota Statute: 152.021.1(5), with reference to: 152.021.3(c)

Maximum Sentence: 40 years or \$1,000,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/08/2026 to 09/08/2026

Control #(ICR#): 26024541

Charge Description: On or between July 8, 2026 and September 8, 2026, in the County of Blue Earth, Minnesota, Andi Tirana Selenica did, within a 90 day period, unlawfully sell one or more mixtures of a total weight of 50 grams or more containing amphetamine, phencyclidine, or hallucinogen or, if the controlled

substance is packaged in dosage units, equaling 200 or more dosage units.

### COUNT III

**Charge: Drugs - 1st Degree - Possess - 500 grams/500 DU or more - amphetamine/PCP/hallucinogens**

Minnesota Statute: 152.021.2(a)(5), with reference to: 152.021.3(a)

Maximum Sentence: 30 years or \$1,000,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/08/2026 to 09/08/2026

Control #(ICR#): 26024541

Charge Description: On or between July 8, 2026 and September 8, 2026, in the County of Blue Earth, Minnesota, Andi Tirana Selenica did unlawfully possess one or more mixtures of a total weight of 500 grams or more containing amphetamine, phencyclidine, or hallucinogen or, if the controlled substance is packaged in dosage units, equaling 500 or more dosage units.

### COUNT IV

**Charge: Drugs - 2nd Degree - Possess 5 kilograms or more of cannabis concentrate**

Minnesota Statute: 152.022.2(a)(6)(ii)

Maximum Sentence: 25 years or to payment of a fine of not more than \$500,000, or both

Offense Level: Felony

Offense Date (on or about): 07/08/2026 to 09/08/2026

Control #(ICR#): 26024541

Charge Description: On or between July 8, 2026 and September 8, 2026, in the County of Blue Earth, Minnesota, Andi Tirana Selenica did unlawfully possess five kilograms or more of cannabis concentrate.

### COUNT V

**Charge: Cannabis - 1st Degree - Possess more than 2 pounds but not more than 10 kg of cannabis flower**

Minnesota Statute: 152.0263.1(1)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/08/2026 to 09/08/2026

Control #(ICR#): 26024541

Charge Description: On or between July 8, 2026 and September 8, 2026, in the County of Blue Earth, Minnesota, Andi Tirana Selenica, did unlawfully possess more than two pounds but not more than ten kilograms of cannabis flower.

### COUNT VI

**Charge: Cannabis - 1st Degree - Possess more than 160 g but not more than 2 kg of cannabis concentrate**

Minnesota Statute: 152.0263.1(2)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/08/2026 to 09/08/2026

Control #(ICR#): 26024541

Charge Description: On or between July 8, 2026 and September 8, 2026, in the County of Blue Earth, Minnesota, Andi Tirana Selenica, did, unlawfully possess more than 160 grams but not more than two kilograms of cannabis concentrate.

### COUNT VII

**Charge: Cannabis - 1st Degree - Possess edible cannabis/hemp edibles/products; > 16 g less than 200 g THC**

Minnesota Statute: 152.0263.1(3)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 07/08/2026 to 09/08/2026

Control #(ICR#): 26024541

Charge Description: On or between July 8, 2026 and September 8, 2026, in the County of Blue Earth, Minnesota, Andi Tirana Selenica, did, unlawfully possess edible cannabis products, lower-potency hemp edibles, or hemp-derived consumer products infused with more than 16 grams but not more than 200 grams of tetrahydrocannabinol.

## STATEMENT OF PROBABLE CAUSE

In the last 90 days, agents of the Minnesota River Valley Drug Task Force began an investigation into the distribution of psilocybin mushrooms, THC cartridges, and THC flower in the Blue Earth County area.

In August of 2026, an undercover agent (UC) began speaking with Andi Tirana Selencia (dob 11/29/1998). Selencia agreed to sell the undercover agent psilocybin mushrooms. Selencia sold UC 63 grams of suspected psilocybin mushrooms in Blue Earth County. During the encounter, Selencia told the undercover agent he was heading to Oregon and Colorado to obtain more product.

Agents conducted extensive surveillance of Selencia. Law enforcement stopped multiple vehicles which were suspected customers of Selencia. Agents discovered significant amounts of THC concentrates and flower. Law enforcement observed Selencia regularly operating a Honda Civic. Agents also observed Selencia going to multiple residences, and numerous individuals coming and going from Selencia's residence in a very short time period. Agents learned that Selencia would provide individuals with loyalty cards with the name "flowerdaddy" on them.

Selencia later agreed to sell UC more psilocybin mushrooms and marijuana flower. Specifically, Selencia agreed to sell 2 pounds of psilocybin mushrooms and 1 pound of marijuana flower. Selencia was arrested before executing this sale.

Agents executed numerous search warrants in Blue Earth County, including at residences associated with Selencia, the Honda Civic they observed Selencia driving, and a residence in which Selencia was suspected of distributing controlled substances at.

A traffic stop was conducted on the Honda Civic. Selencia was driving the vehicle. He was arrested. Inside the Civic, law enforcement found approximately 1,069.5 grams of psilocybin mushrooms, 487 grams of marijuana flower, and 5 grams of THC concentrate.

At a residence associated with Selencia on Highway 22, law enforcement found 273.1 grams of suspected psilocybin mushrooms, 5,165.7 grams of marijuana flower, and 4,530.90 grams of THC concentrate/edibles. Law enforcement also found \$8,550.00 in US Currency, digital scales, and a Springfield XD-S pistol. Law enforcement also found "flowerdaddy" loyalty cards.

Law enforcement also executed a search warrant at 118 Bunting Lane in Mankato. Law enforcement had information and observed surveillance consistent with that Selencia was distributing drugs to this residence. Inside, the residence, law enforcement found in the common area 32.5 grams of psilocybin mushrooms, 40 grams of THC concentrate, and 285 grams of marijuana flower. Also in the common area, law enforcement found a digital scale. The two tenants of the residence, Emmanuel Diderot Dongho Atiodjia and Mohamed Habib Diomande, were arrested inside the residence.

Officers spoke with Diomande, Atiodjia, and Selencia. Selencia wanted a lawyer. Diomande stated that he lived at the 118 Bunting Lane residence with Atiodjia. Diomande stated their shared items would be in the common area. Atiodjia admitted that Selencia drops off "products" at 118 Bunting Lane. Atiodjia says he sometimes is directed to give products to others. He then gets paid for doing this in "product."

Law enforcement observed Selencia conduct at least three separate drug transactions. Selencia told the undercover agent that he obtains products from other states. The circumstances also reveal that Selencia has a high position in the drug distribution hierarchy. The offense also reveals that Selencia was distributing and in possession of controlled substances in quantities substantially larger than the minimum

threshold. Specifically, the evidence supports that law enforcement seized approximately 1,438.1 grams of suspected psilocybin mushrooms, which is over 28 times the minimum threshold for first degree-controlled substance sale of a hallucinogen.

In total, law enforcement seized the following weights tied to Selencia:

5,151.62 grams of THC concentrate;  
6,092.11 grams of marijuana flower; and  
1,438.1 grams of psilocybin mushrooms.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
