The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Violate No Contact Order - Within 10 years of the first of two or more convictions

Minnesota Statute: 629.75.2(d)(1)

Maximum Sentence: 30 days to 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 01/15/2026 to 01/21/2026

Control #(ICR#): 26002093

Charge Description: On or between January 15, 2026 and January 21, 2026, in the County of Blue Earth, Minnesota, Jason Allen Hubbard did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order and the violation within ten years of the first of two or more previous qualified domestic violence-related offense convictions or adjudications of delinquency.

STATEMENT OF PROBABLE CAUSE

On January 21, 2026, at approximately 9:00 AM, Agent Nicole Neudecker, with the Minnesota River Valley Drug Task Force, was monitoring phone calls from the Blue Earth County jail. Agent Neudecker was aware that there was a Domestic Assault No Contact Order (DANCO) prohibiting Jason Allen Hubbard from having contact with Victim 1. Hubbard and Victim 1 have children in common. Hubbard is in custody in the Blue Earth County jail on a domestic assault charge involving Victim 1.

On January 12, 2026, the DANCO was issued and on that same date it was served on Hubbard. The DANCO prohibits Hubbard from having contact with Victim 1, "directly, indirectly or through others, in person, by telephone, in writing, electronically or by any other means...."

Agent Neudecker listened to the phone calls and was able to identify Hubbard's voice as well as Victim 1's voice. Agent Neudecker discovered that there were 19 phone calls from Hubbard to Victim 1 between January 15, 2026, and January 21, 2026.

Ofc. Sean McClinton conducted follow-up investigation. Ofc. McClinton listened to the phone calls and identified Hubbard's voice as well as the voice of Victim 1. Ofc. McClinton made contact with Victim 1. Victim 1 admitted to the communication with Hubbard.

A review of Hubbard's criminal history shows at least two qualified domestic violence – related offense convictions. On January 29, 2016, Hubbard was convicted of Domestic Assault in Scott County file 70-CR-15-19719. On May 30, 2018, Hubbard was convicted of a DANCO Violation in Blue Earth County file 07-CR-16-347.

Hubbard is currently in custody in the Blue Earth County jail on a felony domestic assault file involving the same victim. A warrant for his arrest is requested.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
