The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

#### **COUNT I**

**Charge: Domestic Assault - By Strangulation** 

Minnesota Statute: 609.2247.2, with reference to: 609.2247.2

Maximum Sentence: 3 years or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 04/11/2025

Charge Description: On or about April 11, 2025, in the County of Blue Earth, Minnesota, Bradley Alan Suess did assault a family or household member by strangulation.

#### **COUNT II**

**Charge: Domestic Assault-GM-Subsequent Violation**

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Charge Description: On or about April 11, 2025, in the County of Blue Earth, Minnesota, Bradley Alan Suess, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflicted or attempted to inflict bodily harm upon another and has a previous qualified domestic violence-related offense conviction or an adjudication of delinquency within ten years.

#### STATEMENT OF PROBABLE CAUSE

On April 11, 2025, officers of the Mankato Department of Public Safety commenced an investigation of an incident where Bradley Alan Suess (DOB 06/02/1992) was reported to have assaulted Victim 1, a family member.

Officers learned that Suess had choked Victim 1 at a Mankato residence. Victim 1 was leaving the residence when there was an altercation. Suess intervened, knocking some leftover food from her arms onto the floor. Suess yelled at Victim 1 to "get out." Sues then grabbed Victim 1 by the neck and dragged her toward the entryway, lifted her by the neck and began to slam Victim 1's head against a wall. Suess chocked Victim 1 making her unable to breath and that everything "went black" as Suess choked her. Officers observed bruising on Victim 1's neck. Suess had been intimidating Victim 1 in the past, but this is the first time Suess hurt Victim 1.

Four officers went to Suess' residence to arrest Suess. Suess was not home. An officer was able to contact Suess by telephone and Suess stated that he knew that four officers went to his house. The officer told Suess that they had probable cause to arrest him. Suess told the officer he was out of town.

Suess was convicted of Misdemeanor Domestic Assault on September 27, 2021, in Blue Earth County File 07-CR-19-711.

Law enforcement has been unable to physically locate Suess since the incident. Suess is an active danger to the Victim and a Complaint Warrant is requested.

#### SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:

(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or

(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
