The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Assault - 4th Deg - Physician, nurse or other emergency room personnel**

Minnesota Statute: 609.2231.2(a)(2)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 04/12/2026

Control #(ICR#): 26011050

Charge Description: On or about April 12, 2026, in the City of Mankato, County of Blue Earth, Minnesota, Skylar Michelle Clancy, did, physically assault a physician, nurse, or other person providing health care services in a hospital emergency department.

## STATEMENT OF PROBABLE CAUSE

On April 12, 2026, at approximately 3:50 am, Skylar Michelle Clancy, DOB: 01/29/1999, was at a local hospital. Clancy caused a disturbance at the hospital and was banging on windows and Clancy attempted to exit through a locked exit door. Victim 1 is a Registered Nurse and was on duty in the hospital and responded to Clancy's area. Clancy's began yelling at the nurse and security members who responded to the area and was pacing in the hallway. Clancy had to be placed into a restraint chair, and as Victim 1 and security were attempting to secure the straps to the chair, Clancy spit at Victim 1 and security staff, hitting Clancy in the face, neck and hair with her spit.

Mankato Public Safety Officer Connor Coutier took witness statements and reviewed surveillance video of the incident on April 16, 2026. Officer Coutier spoke to Clancy, who did not dispute the statements made by Victim 1 or other witnesses of the incident.

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
