The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNTI

Charge: Traffic-DL-Driving after cancellation-inimical to public safety

Minnesota Statute: 171.24.5

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 10/11/2025

Control #(ICR#): 25017157

Charge Description: On or about October 11, 2025, in the City of Mankato, County of Blue Earth, Minnesota, Dawn Marie Smith did after being given notice, or reasonably should have known of the cancelation, disobeyed the order by operating in this state any motor vehicle, the operation of which requires a driver's license, while her license or privilege was canceled; and the Commissioner of the Department of Public Safety has determined that the operation of a motor vehicle on the highways by the person would be inimical to the public safety or welfare.

STATEMENT OF PROBABLE CAUSE

On October 11, 2025, Blue Earth County Sheriff Deputy Brandon Kowalski was on patrol at the intersection of Hemlock Rd/Co Rd 90, when he observed a black Buick Century drive past. Upon running the license plate number through MN DVS, the Deputy learned that the registered owner of the vehicle was Canceled-Inimical to Public Safety (DAC-IPS). The Deputy then confirmed that Dawn Marie Smith, DOB: 06/06/1966 was confirmed as DAC-IPS.

Deputy Kowalski initiated a traffic stop on the vehicle, walked to the driver side window, and confirmed the driver was Smith. The Deputy explained to Smith the reason for the stop and asked her if she was aware that her driving status was DAC-IPS. She responded that she was not aware that her license had been suspended. The Deputy asked if she had any prior DWI arrests, as in his experience, that is normally how drivers obtain DAC-IPS status. Smith stated that she had a blood draw Warrant done after a motorcycle crash "not long ago" from Brown County but stated that she had not heard anything after on the status of that investigation.

Based on the DVS record, Smith was notified of the cancelation of her license on September 10, 2025. As of September 30, 2025, her driver's license status was listed as "IPS Cancelled."
