The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Obstruct Legal Process-Interfere w/Peace Officer

Minnesota Statute: 609.50.1(2), with reference to: 609.50.2(2)

Maximum Sentence: 364 days or \$3,000 fine, or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 08/22/2026

Control #(ICR#): 26026809

Charge Description: On or about August 22, 2026, in the County of Blue Earth, Minnesota, Pedro Henrique Cerqueira Passos Ferraz did, intentionally, obstruct, resist, or interfere with a peace officer while the officer was engaged in the performance of official duties and the act was accompanied by force or violence or the threat thereof.

COUNT II

Charge: Liquor-Consumption by persons under 21

Minnesota Statute: 340A.503.1(a)(2), with reference to: 340A.703

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 08/22/2026

Control #(ICR#): 26026809

Charge Description: On or about August 22, 2026, in the County of Blue Earth, Minnesota, Pedro Henrique Cerqueira Passos Ferraz did, while under the age of 21 years, consume an alcoholic beverage.

COUNT III

Charge: Drivers' Licenses - Display/Possess Fictitious or Fraudulently Altered DL or MN ID

Minnesota Statute: 171.22.1(1), with reference to: 171.22.2

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 08/22/2026

Control #(ICR#): 26026809

Charge Description: On or about August 22, 2026, in the County of Blue Earth, Minnesota, Pedro Henrique Cerqueira Passos Ferraz, did, display, cause or permit to be displayed, or have in possession, any fictitious or fraudulently altered driver's license or Minnesota identification card.

STATEMENT OF PROBABLE CAUSE

On August 22, 2026, Officers of the Mankato Department of Public Safety observed a disturbance outside Residence 1 in the City of Mankato. Officers observed numerous people pushing and shoving each other.

Officer Wagner approached the door to Residence 1. A male later identified as Pedro Henrique Cerqueira Passos Ferraz slammed the door to the residence into Officer Wagner multiple times. Officer Gelle took a hold of Ferraz's right arm and told him to step outside. Ferraz refused and braced himself against a door to prevent Officer Gelle from removing him. While escorting Ferraz he planted his feet and pushed and pulled away from Officer Gelle.

Ferraz admitted that he was only 20 years old and had been consuming alcohol. Ferraz registered a .159 BAC on a PBT.

During a search of Ferraz, officers located a fake identification card identifying Ferraz as over 21 years old in a wallet containing his real MN driver's license.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
