The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Drugs - 3rd Degree - Possess - Methamphet/Amphetamine in School/Park/Pub Housing Zone

Minnesota Statute: 152.023.2(a)(6), with reference to: 152.023.3(a)
Maximum Sentence: 20 years or \$250,000, or both
Offense Level: Felony

Offense Date (on or about): 06/11/2026

Control #(ICR#): 26018213

Charge Description: On or about June 11, 2026, in the County of Blue Earth, Minnesota, Jared Anthony Hein did unlawfully possesses one or more mixtures containing methamphetamine or amphetamine in a school zone, a park zone, a public housing zone, or a drug treatment facility.

COUNT II

Charge: Drugs - 5th Degree - Possess Schedule 1,2,3,4 or paraphernalia residual - Not cannabis/hemp

Minnesota Statute: 152.025.2(a)(1), with reference to: 152.025.4(b)
Maximum Sentence: 5 years or \$10,000 fine, or both
Offense Level: Felony

Offense Date (on or about): 06/11/2026

Control #(ICR#): 26018213

Charge Description: On or about June 11, 2026, in the County of Blue Earth, Minnesota, Jared Anthony Hein, did unlawfully possess one or more mixtures containing a controlled substance classified in schedule I, II, III, or IV, except cannabis flower, cannabis products, lower-potency hemp edibles, or hemp-derived consumer products or a residual amount of one or more mixtures of controlled substances contained in drug paraphernalia, and the mixture does not include any amount of a controlled substance

in a fluid used in a water pipe and said controlled substance was more than .25 grams or 1 dosage unit

STATEMENT OF PROBABLE CAUSE

On June 11th, 2026, Officer Herwig was dispatched to a report of narcotics found at Business 1 within the City of Mankato. Officer Herwig met with Witness 1, a Business 1 security worker. Witness 1 informed Officer Herwig that Witness 2 had found the narcotics. Witness 1 gave Officer Herwig a small bag containing a white crystal-like substance that later field-tested positive for methamphetamine. The substance weighed .86 grams.

Officer Herwig spoke with Witness 2 who stated that an individual, later identified as Jared Anthony Hein (DOB: 12/18/1994), dropped the small bag of narcotics on to the conveyer belt while paying for his items. Officer Herwig viewed surveillance footage and observed the small plastic bag containing methamphetamine falling out of Hein's hand and onto the conveyer belt as Hein handed Witness 2 cash to pay for Hein's items.

Business 1 is located within a school, park, or public housing zone as defined in Minn. Stat. § 152.01 and the Mankato Drug Enforcement Zone.

Hein has a prior conviction for Felony 5th Degree Controlled Substance Possession in 27-CR-21-206 (convicted 05/04/2021).

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
