The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Possession of Shoplifting Gear**

Minnesota Statute: 609.521(b)

Maximum Sentence: 3 years or \$5,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 02/15/2026

Control #(ICR#): 26004794

Charge Description: On or about February 15, 2026, in the County of Blue Earth, Minnesota, Shawnyell D Younger, did have in possession any device, gear, or instrument designed to assist in shoplifting or defeating an electronic article surveillance system with intent to use the same to shoplift and thereby commit theft.

**COUNT II**

**Charge: Theft-Take/Use/Transfer Movable Prop-No Consent**

Minnesota Statute: 609.52.2(a)(1), with reference to: 609.52.3(5)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 02/15/2026

Control #(ICR#): 26004794

Charge Description: On or about February 15, 2026, in the County of Blue Earth, Minnesota, Shawnyell D Younger did, intentionally and without claim of right, take, use, transfer, conceal or retain possession of the movable property of another without the other's consent and with intent to deprive the owner permanently of possession of the property.

## STATEMENT OF PROBABLE CAUSE

In the afternoon on February 15, 2026, officers from the Mankato Department of Public Safety were dispatched to Business 1 after Witness 1 reported two females shoplifted from the business. Witness 1 provided police with a license plate number for a related vehicle and descriptions of the suspects. Witness 1 said the suspects went to Business 2 after leaving Business 1.

Witness 1 showed Officer Hermanson a video surveillance recording of the females leaving Business 1 with a black, wheeled cart and other items, without paying for them. The approximate value of the items is between \$185 and \$235.

Officer Hermanson observed in the parking lot a vehicle with the license plate number provided by Witness 1. Inside the vehicle Hermanson could see a black, wheeled cart with other items.

Officer Marzolf located the suspect females at the north end of the parking lot and identified them as Ashley Jonell Kilgore (DOB: 02/06/1988) and Shawnyell D. Younger (DOB: 12/16/1985).

Officer Hermanson spoke to Kilgore and Younger and confronted them about the recording Hermanson viewed that showed Kilgore and Younger taking the black, wheeled cart from Business 1. Kilgore and Younger admitted to taking the cart.

Officer Marzolf located stolen items from Business 2 in Kilgore's and Younger's belongings.

Inside the vehicle associated with Kilgore and Younger, police found two tote bags with stolen property. Witness 1 said Kilgore and Younger used those bags to conceal stolen items from Business 1.

Officer Hermanson located on Kilgore's person a magnetic anti-theft tag removal device.

## SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:  
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or  
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
