The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Threats of Violence-Reckless Disregard Risk

Minnesota Statute: 609.713.1

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 05/31/2026

Control #(ICR#): 26016879

Charge Description: On or about May 31, 2026, in the County of Blue Earth, Minnesota, Timothy Lynn Brunz, did, threaten, directly or indirectly, to commit any crime of violence with purpose to terrorize another, or in a reckless disregard of the risk of causing such terror.

STATEMENT OF PROBABLE CAUSE

On May 31, 2026, officers in Mankato Department of Public Safety were dispatched to a residence in Mankato, Minnesota, Blue Earth County. Timothy Lynn Brunz called 911 wanting to report that his brother who lives in Alaska was harassing him. Around the same time, Victim 1 call 911 and reported that Brunz had threatened to shoot her.

Officers arrived and made contact with Brunz. Officers also contacted Victim 1. Victim 1 reported that she was going by Brunz's residence and he began screaming at her. Victim 1 said Brunz said the following, "I'm gonna blast you... Get the fuck out of here you're nothing but a stupid whore, I'm gonna blast ya... You fucking whore, you're nothing but a stupid whore, I'm gonna blast ya." Brunz then made a finger gun gesture with his right hand while he was saying this to her. Brunz then said he was going to "shoot her", and he was "going to go get his gun."

Victim 1 said she was fearful Brunz was going into the house to get a gun. Victim 1 was scared for her safety, so she left the area.

Brunz was arrested.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
