COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Emergency Telephone Calls/Communications - Interrupt, Interfere, Impede, Disrupt 911 Call

Minnesota Statute: 609.78.2(1), with reference to: 609.78.2

Maximum Sentence: 364 days or \$3,000 fine or both

Offense Level: Gross Misdemeanor

Offense Date (on or about): 12/17/2023

Control #(ICR#): 23020576

Charge Description: On or about December 17, 2023 at 10:00 PM, in the County of Blue Earth, Minnesota, Kyle Daniel Tischler did and intentionally interrupt, disrupt, impede, or interfere with an emergency call or intentionally prevent or hinder another from placing an emergency call.

COUNT II

Charge: Domestic Assault-Misdemeanor-Commits Act to Cause Fear of Immediate Bodily Harm or Death

Minnesota Statute: 609.2242.1(1), with reference to: 609.2242.1(1)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 12/17/2023

Control #(ICR#): 23020576

Charge Description: On or about December 17, 2023 at 10:00 PM, in the County of Blue Earth, Minnesota, Kyle Daniel Tischler, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, commit an act with intent to cause fear in another of immediate bodily harm or death.

COUNT III

Charge: Domestic Assault-Misdemeanor-Intentionally Inflicts/Attempts to Inflict Bodily Harm on Another

Minnesota Statute: 609.2242.1(2), with reference to: 609.2242.1(2)

Maximum Sentence: 90 days or \$1,000 fine, or both.

Offense Level: Misdemeanor

Offense Date (on or about): 12/17/2023

Control #(ICR#): 23020576

Charge Description: On or about December 17, 2023, in the County of Blue Earth, Minnesota, Kyle Daniel Tischer, did, against a family or household member, as defined in M.S.A. 518B.01 Subd. 2, intentionally inflict or attempt to inflict bodily harm upon another.

STATEMENT OF PROBABLE CAUSE

On December 17, 2023, law enforcement officers were dispatched to a report of a domestic disturbance at a residence in Vernon Center. Dispatcher could hear a female crying and the call was disconnected.

Victim 1 reported to officers that they had gotten into an argument with Kyle Daniel Tischer (DOB 06/07/1991). The argument was about Tischer spending the evening in their garage drinking. The argument turned physical and Tischer pushed Victim 1 onto the floor.

Victim 1 called 9-1-1 and was on the phone with dispatchers when Tischer came towards her and hung up the phone. Officers were informed before arrival at the scene that the 9-1-1 call had been disconnected.

Officers noted Tischer was slurring his speech. Tischer PBT'd at .176 BAC.

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
