The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Domestic Abuse; Violates order for protection w/in 10 years of previous conviction/adj of delinq.**

Minnesota Statute: 518B.01.14(c)

Maximum Sentence: 10 days to 364 days or \$3,000 fine, or both.

Offense Level: Gross Misdemeanor

Offense Date (on or about): 02/04/2024

Control #(ICR#): 24001926

Charge Description: On or about February 4, 2024, in the County of Blue Earth, Minnesota, Kyle Rodney Boeck did knowingly violate an order for protection within ten years of a previous qualified domestic violence-related offense conviction or adjudication of delinquency,

## **STATEMENT OF PROBABLE CAUSE**

On February 4, 2024, Deputy Othoudt of the Blue Earth County Sheriff's office was speaking with Protected Party 1 who resides in Blue Earth County regarding an order for protection that prohibits Kyle Rodney Boeck from having any contact with her. While Deputy Othoudt was speaking with Protected Party 1, Boeck called Protected Party 1. Protected Party 1 answered the phone and spoke with Boeck.

Deputy Othoudt located Boeck who admitted to calling Protected Party 1. Boeck stated that Protected Party 1 constantly calls and texts him.

Boeck was served the order for protection on February 1, 2024. Boeck was convicted of threats of violence in 2016 in court file 83-CR-16-183.
