The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

Charge Description: On or about October 21, 2025, in the County of Blue Earth, Minnesota, Stephanie Kay Kryzer did violate a Domestic Abuse No-Contact Order and the respondent or person to be restrained knew of the existence of the order.

STATEMENT OF PROBABLE CAUSE

On October 20, 2025, Deputy William Davis responded to the area in Blue Earth County to investigate a reported disturbance. Dispatch advised that Witness called 911 and reported that Witness 1 could hear a man and woman yelling at each other in the area. Deputy Grassman also responded to the call and observed a woman inside the fenced property of a business. Deputies entered the property to further investigate. Once inside law enforcement identified Victim protected party and Stephanie Kay Kryzer (DOB 05/19/1980). Kryzer indicated that she and Victim had gotten a ride to the business in which she is a customer, and Victim came with. Kryzer advised that she and victim got into an argument and began yelling and screaming at each other.

Dispatch advised that there was a DANCO in place between Kryzer and Victim with Victim being the protected party. Kryzer indicated that she knew about the DANCO. While revieing Kryzer's criminal history law enforcement observed that she has been cited for previously Violating the same DANCO order.
