COMPLAINT

Order of Detention

The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

COUNT I

Charge: Assault-5th Deg-2/More Prev Convict in 3 years

Minnesota Statute: 609.224.4(b)

Maximum Sentence: 5 years or \$10,000 fine, or both

Offense Level: Felony

Offense Date (on or about): 01/28/2026

Control #(ICR#): 26002768

Charge Description: On or about January 28, 2026, in the County of Blue Earth, Minnesota, Kayla Sue Tyser did commit an act with intent to cause fear in another of immediate bodily harm or death and has two or more previous qualified domestic violence related offense convictions or adjudications of delinquency within the previous 3 years.

STATEMENT OF PROBABLE CAUSE

Just after midnight on January 28, 2026, Kayla Sue Tyser (DOB: 01/22/1993) called Blue Earth County Dispatch and reported Tyser tried to attack staff at Business 1--Tyser's residence in Blue Earth County--using Tyser's hands and chairs.

When Officer Hermanson spoke to Tyser at Business 1, Tyser told Hermanson Tyser had thrown multiple chairs at staff with the intent to harm staff. Tyser said Tyser wanted to kill staff.

Victim 1, a staff member at Business 1, told Officer Hermanson Tyser threw a chair at Victim 1, chased Victim 1 around the kitchen, and stated Tyser wanted to harm Victim 1. Victim 1 said Tyser made a comment to Victim 1 about snapping Victim 1's neck.

Tyser has been convicted of the following qualified domestic violence-related offenses in the last three years: (1) Assault in the 4th Degree – Court File No. 07-CR-25-4260 – convicted January 26, 2026; (2) Threats of Violence – Court File No. 07-CR-25-1667 – convicted January 26, 2026; (3) Assault in the 5th Degree – Court File No. 07-CR-25-4056 – convicted December 10, 2025; and (4) Assault in the 5th Degree – Court File No. 07-CR-25-2841 – convicted December 10, 2025.

SIGNATURES AND APPROVALS

Complainant requests that Defendant, subject to bail or conditions of release, be:
(1) arrested or that other lawful steps be taken to obtain Defendant's appearance in court; or
(2) detained, if already in custody, pending further proceedings; and that said Defendant otherwise be dealt with according to law.
