The Complainant submits this complaint to the Court and states that there is probable cause to believe Defendant committed the following offense(s):

**COUNT I**

**Charge: Possess child sexual abuse material; Prior conviction or adjudication**

## STATEMENT OF PROBABLE CAUSE

In 2019, Robert Sean Pasch (dob 9/11/1972) was convicted of two counts of disseminating child pornographic work in Hennepin County in court file 27-CR-18-73. He is required to register as a predatory offender because of that.

In January of 2026, Special Agent Kevin Waterstreet with the Minnesota Bureau of Criminal Apprehension became aware of a tip regarding Pasch. A witness disclosed to law enforcement that Pasch told the witness that he had a "child fetish" and wanted the witness to role play as a child. The witness also stated that Pasch told the witness he was having sex with 15-year-old boys and girls and recording it.

Through investigative measures, Agent Waterstreet was able to determine that Pasch was residing at a residence in Mankato, Minnesota, Blue Earth County. Agent Waterstreet went to that residence and made contact with Pasch.

Agent Waterstreet spoke with Pasch. Pasch denied ever producing any child pornography. Pasch voluntarily provided Agent Waterstreet a tablet and provided a passcode so Agent Waterstreet could look through it. Pasch admitted he used the tablet to lookup child sexual abuse materials (CSAM) and there would be CSAM on the tablet.

Agent Waterstreet took possession of the tablet. A warrant was obtained to search the tablet. Agent Waterstreet observed 80 image files which constitute CSAM under Minnesota law. Agent Waterstreet also observed approximately 42 videos which constitute CSAM materials. Agent Waterstreet observed the following videos which appeared to be downloaded or saved to the device on separate dates:

Video file was taken from an adult males point of view pointing downwards toward the ground. The video showed a prepubescent female child, approximately 8-10 years old, from the chest down lying on their back. The child has no pants or underwear on and has their legs spread. The adult male is penetrating the child's vagina with his penis. The adult male removes his penis from the child's vagina and ejaculate is observed coming from the child's vaginal opening. The male then inserts his index finger into the child's vagina. The video was approximately 1:00 in length

Video file showed a pubescent male wearing a backwards hat, on his knees in front of another pubescent male. The males appear to be approximately 10-13 years old. The male on his knees was performing oral sex on the other male. At approximately 13 seconds into the video, the other male began performing oral sex on the male wearing the backwards hat. The video was approximately 00:59 in length.

Video file showed three prepubescent male children, all approximately 8-10 years old. The three children were completely nude lying on a bed which was red in color. The children were seen performing oral sex on one another and masturbating. The video contained a red text over the bottom left corner of the screen which read "contact us: kpb84.com"

The video contained two pubescent males who were approximately 11-14 years old. The males are completely nude in a bedroom setting. The males began rubbing their penises together while kissing one another. The males began performing oral sex on each other before one male inserts his penis into the other males anus. The video was approximately 07:48 in length. The video contained a red text in the lower right corner which read "contact me: ver5xt.de"

The video contained a pubescent male lying on a bed, fully nude. Based on the size of the males hips and legs, it was estimated he was between 11 and 14 years old. The male was masturbating. An adult male entered the view of the video and penetrated the pubescent male's anus with his penis. The adult male continued to have anal sex with the pubescent male before removing his penis from his anus and ejaculating onto his stomach. The video was approximately 00:54 in length. The video contained a red text in the lower left corner which read: "contact us: kpb84.com"

The video contained a prepubescent male and a prepubescent female child, both fully nude on a bed together. The children appeared to be approximately 8-10 years old. The female child was performing oral sex on the male child. The female child then laid on her back and the male child inserted his penis into her vagina. Towards the end of the video, someone off the screen is seen handing the female child a sex toy before the video ends. The video was approximately 00:53 in length. The video contained a red text in the lower right corner which read: "contact me: tor9kb.in"

Based on training and experience, Agent Waterstreet is aware that the modified date and time is indicative of the download or saved date and time.

Pasch was arrested on March 27, 2026.
